# **DISCUSSION:**

Due to the closure of the Health Services Agency (HSA) Gastrointestinal Lab in July 2009, certain specialized equipment can no longer be used. Advanced Gastrointestinal procedures are now performed at Doctors Medical Center.

Doctors Medical Center (DMC), has established itself in the Central Valley as a provider of quality medical care and treatment. The 465-bed, multi-specialty hospital is part of Tenet Health System, a nationwide provider of health care services. Doctors Medical Center is fully accredited by the Joint Commission on Accreditation of Healthcare Organizations, and is licensed by the state of California.

DMC has agreed to exchange of a variety of surplus medical equipment from HSA for a Sigmoidoscopy Cart, valued at \$40,000:

Transfer of the surplus items to DMC will reduce the amount of surplus goods at HSA and assist both HSA and DMC in meeting their mission to provide high-quality, cost-effective and state-of-the-art medical services in a compassionate, caring manner responsive to the needs of the community.

Alternatively, General Services Agency would place the equipment for auction. The combined value of the surplus medical is estimated to be \$10,200.
