Approval to Adopt Plans and Specifications for the ARRA 2009 Cape Seal Project, Federal Project No. ESPL-5938(164), and Set the Bid Opening Date

DISCUSSION:

The ARRA 2009 Cape Seal will consist of a Type II Slurry Seal over a 3/8 inch Polymer Modified Chip Seal. The Cape Seal will be placed over approximately 55 miles of road surfaces creating a smooth, durable, water resistant pavement surface. In addition to the 55 miles of base roads, there are six (6) alternate roads that total an additional 42 miles. If the winning bid for the base roads is below the anticipated cost, then roads from the alternate road list can be added to the contract to utilize any excess funding. New striping will be applied on the centerline and edge lines as well as various pavement markings.

All preliminary engineering was done in-house by Public Works staff.

The following roads are included in the program:

2. West Main Street (1,400 feet east of Crows Landing Road to Washington Road)
3. Crows Landing Road (1,400 feet north of West Main Street to 1,000 feet south of Grayson Road)
4. Crows Landing Road (Hwy 33 to 1,400 feet south of West Main Street)
5. Fink Road (Hwy 33 to Ward Ave)
6. Carpenter Road (West Main Street to Hatch Road)
7. Carpenter Road (Crows Landing Road to West Main Street)
8. Grayson Road (Hwy 33 to Carpenter Road)
9. Kasson Road (Maze Blvd to Stanislaus County Line)
10. River Road (Maze Blvd to Grayson Road)

Alternate Roads

1. Geer Road (Taylor Road to Santa Fe Ave)
2. Gratton Road (East Ave to Mt. Bullion)
3. Monte Vista Ave (Santa Fe Ave to Hickman Road)
4. Hickman Road (Monte Vista Ave to East Ave)
5. Keyes Road (Santa Fe Ave to Hickman Road)
6. Gratton Road (Keyes Road to Whitmore Ave)
7. Rogers Road (Hwy 33 to Patterson City Limits)
8. Ladd Road (850 feet west of McHenry Ave to Stoddard Road)
9. Bradbury Road (Crows Landing Road to Washington Road)
10. Whitmore Ave (Faith Home Road to Mountain View Road)
11. Service Road (Moore Road to Santa Fe Rail Road Right of Way)
12. Washington Road (Stanislaus County Line to Turlock City Limits)
13. Washington Road (Turlock City Limits to Monte Vista Ave)
14. Monte Vista Ave (Washington Rd to Turlock City Limits)
15. Golden State Blvd (Keyes Road to Turlock City Limits)
