DISCUSSION:

In 1978, California Municipal Courts stopped setting penalty schedules for violations of county and municipal code parking regulations. The courts placed this authority with the local government. In 1993, AB 408 revised the procedures for processing and adjudicating parking law offenses. The bill required courts to transfer the processing of parking offenses to issuing agencies. Consequently, the parking violations have been removed from the Uniform Bail and Penalty Schedules. Parking violations essentially became an administrative action issued by local government.

Currently, the Sheriff's Department is vested with the responsibility of enforcing parking laws in the unincorporated areas of the County and the processing and collection of the parking penalties is handled through a contract for services with the City of Inglewood.

Historically the parking penalties have been updated by the Sheriff's Department Traffic Unit by conducting a survey of neighboring jurisdictions every few years. The Sheriff's Department surmises that the County has not increased the base penalty for parking violations for many years and recommends adopting the uniform parking penalty schedule as outlined in Exhibit A.

A survey of the neighboring jurisdictions was conducted in partnership with the City of Ceres. In addition the staff reviewed the State of California Judicial Council recommendations for parking violation penalties. The survey is attached as Exhibit B. In many cases, the penalties remain unchanged. There are 4 new penalties, a decrease in 4 penalties, 14 penalties increase by \$5.00, 8 penalties increase between \$10.00-\$45.00 and the handicapped placard violation penalty increases by \$250. The proposed penalty changes are designed to achieve some uniformity in the schedule.

FEE AUTHORITY:

General Authority

GC 54985. (a) Notwithstanding any other provision of law that prescribes an amount or otherwise limits the amount of a fee or charge that may be levied by a county, a county service area, or a county waterworks district governed by a county board of supervisors, a county board of supervisors shall have the authority to increase or decrease the fee or charge, that is otherwise authorized to be levied by another provision of law, in the amount reasonably necessary to recover the cost of providing any product or service or the cost of enforcing any regulation for which the fee or charge is levied. The fee or charge may reflect the average cost of providing any product or service or enforcing any regulation. Indirect costs that may be reflected in the cost of providing any product or service or the cost of enforcing any regulation shall be limited to those items that are included in the federal Office of Management and Budget Circular A-87 on January 1, 1984.

Parking Penalties

40200. (a) Any violation of any regulation that is not a misdemeanor governing the standing or parking of a vehicle under this code, under any federal statute or regulation, or under any

FEE AUTHORITY (continued):

ordinance enacted by local authorities is subject to a civil penalty. The enforcement of those civil penalties shall be governed by the civil administrative procedures set forth in this article.

40203. The notice of parking violation shall be accompanied by a written notice of the amount of the parking penalty due for that violation, the address of the person authorized to receive a deposit of the parking penalty, a statement in bold print that payments of the parking penalty for the parking violation may be sent through the mail, and instructions on obtaining information on the procedures to contest the notice of parking violation.

40203.5. (a) The schedule of parking penalties for parking violations and late payment penalties shall be established by the governing body of the jurisdiction where the notice of violation is issued. To the extent possible, issuing agencies within the same county shall standardize parking penalties.

40203.5. (b) Parking penalties under this article shall be collected as civil penalties.

PUBLIC HEARING:

Pursuant to Government code section 54985, the County is required to hold a scheduled public hearing prior to levying a new charge or increasing an existing charge.

POLICY ISSUES:

An ordinance of the Board of Supervisor's is required to increase or establish those penalty charges. The Board must decide the potential impacts on the community and whether the request will assist the Sheriff's Department in meeting the Board's priority of ensuring a safe community and efficient government operations.
