Approval for Nineveh Outreach to Have Exclusive Use Utilizing Areas of Oregon Drive and Salida Neighborhood Parks on Saturdays from March 27, 2010 through December 18, 2010 to Provide Food and Clothing to Needy and Low Income Families and Waiver of Fees for Exclusive Use

DISCUSSION

A request has been received from Nineveh Outreach, a division of the Calvary Temple Worship Center to have exclusive use utilizing areas of Oregon and Salida Neighborhood Parks for their 12th year of serving the County's children, families, and individuals who are in need of food and clothing. Nineveh Outreach will begin utilizing Oregon Park (Attachment A) each Saturday beginning March 27, 2010, from 8:00 a.m. to 12:00 p.m. and ending Saturday, December 11, 2010. Salida Park (Attachment B) will be utilized only on the first and third Saturdays of each month beginning March 27, 2010, from 8:00 a.m. to 12:00 p.m. and ending on Saturday, December 18, 2010.

Nineveh Outreach is a longstanding outreach organization serving the community since 1997. Now, in its 12th year of operations, this organization distributes prepackaged food and clothing to the County's community of children, families, seniors, and other individuals in need. The event features recorded music playing in the parks, presentations from the children and shared messages of hope and faith. In 2009, over 100 children participated in the presentations each week with an average of 191 families per week at both Oregon and Salida Parks; almost 12,000 bags of groceries were distributed. Over 300 children and families were provided gifts and meals during the December holiday season. Additionally, Nineveh's Hope Medivan became licensed and was used at Oregon Park during the months of October and November; for the 2010 calendar year, this will be scheduled once a month.

The Department of Parks and Recreation does not have any objection to this request for exclusive use and as such necessitates Nineveh Outreach, a division of the Calvary Temple Worship Center to adhere to the following requirements:

- By Thursday, March 25, 2010, no later than 5:00 p.m., require Nineveh Outreach, a division of Calvary Temple Worship Center, to provide the Department of Parks and Recreation its Certificate of Insurance with a minimum liability coverage of \$1 million and the accompanying endorsement naming Stanislaus County as an additional insured.
- A Hold Harmless Agreement (Organization) is required. The original agreement must be completed and returned by Thursday, March 25, 2010, no later than 5:00 p.m.
- A key to Oregon Park restrooms will be issued to Nineveh Outreach. Nineveh Outreach staff/volunteers will be responsible for ensuring the restrooms are free of litter, debris, and are clean prior to leaving the park. Should additional supplies be needed, Nineveh Outreach staff will contact Department staff to make arrangements for restocking. Should a maintenance issue arise, Nineveh Outreach staff will ensure Department staff is made aware of the concern.

- Should a key need to be issued for the Salida Park restrooms Nineveh Outreach staff shall coordinate with Salida Little League. The League has a contractual agreement with the Department and are responsible for janitorial and maintenance issues.
- All irrigation concerns will be coordinated with Department staff to ensure grounds are useable and do not interfere with activities.
- Should an annual community event be scheduled and authorized by the Board of Supervisors at either park location, said event will take precedence over Nineveh Outreach activities unless mutually agreed upon by the community event organizer and Nineveh Outreach staff.
- No alcohol shall be sold, served, or consumed during Nineveh Outreach activities.
- The expected number of persons for each park per event date is 100.
- The park is to be left in a clean condition free of litter and debris.

POLICY ISSUE (S)

The Board should determine if approving this exclusive use request and waiver of fees is consistent with its priority of effective partnerships and its value of caring while showing concern for the well being of others.


