RESOLUTION NO 2010-15

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF HUGHSON, CALIFORNIA, REQUESTING THE BOARD OF SUPERVISORS OF THE COUNTY OF STANISLAUS TO PERMIT THE COUNTY ELECTIONS OFFICIAL TO RENDER SPECIFIED ELECTION SERVICES TO THE CITY OF HUGHSON FOR A SPECIAL MUNICIPAL RECALL ELECTION TO BE HELD ON TUESDAY, AUGUST 24, 2010, PURSUANT TO DIVISION 11, CHAPTER 3, ARTICLE 3. OF THE ELECTIONS CODE AND ALLOW FOR THE APPROPRIATION OF \$23,000.00 TO COVER THE COSTS OF THE ELECTION**

**WHEREAS**, the City Council of the City of Hughson issued an order calling for a Special Municipal Recall Election to be held on Tuesday, August 24, 2010, for the purpose of the recall of Councilmember Thomas Crowder, Councilmember Doug Humphreys, and Councilmember Ben Manley, and

**WHEREAS**, if the recalls were to prevail, voters would elect a candidate to fill any of the unexpired terms of office, and

**WHEREAS**, the City of Hughson has traditionally rendered election services from the Stanislaus County Registrar of Voters Office during regular and special elections, and requests to render specified election services from the County as they are the entity most appropriately equipped to conduct, canvas, and declare the results of an election in the manner provided by law, and

**WHEREAS**, it is desirable that the Stanislaus County Registrar of Voters Office provide rendered specified election services to the City of Hughson for a stand-alone, Special Municipal Recall Election.

**NOW THEREFORE THE CITY COUNCIL OF THE CITY OF HUGHSON, CALIFORNIA, DOES RESOLVE, DECLARE, DETERMINE, AND ORDER AS FOLLOWS:**

Section 1. That the County Board of Supervisors is requested to issue instructions to the County Registrar of Voters Office to take any steps necessary to render specified services for the holding of a Special Municipal Recall Election of the City of Hughson.

Section 2. That the City of Hughson recognizes that costs will be incurred by the County for providing such services to hold a stand-alone recall election and, therefore, agrees to reimburse the county for such costs.

Section 3. That Stanislaus County Registrar of Voters has estimated an election cost of \$13,500.00 to \$22,750.00 and that the maximum of \$23,000.00 be appropriated to cover the costs incurred.

Section 4. That the City Clerk is hereby directed to file a certified copy of this resolution with the Board of Supervisors and the County Registrar of Voters Office of the County of Stanislaus upon adoption.

Section 5. That pursuant to Elections Code §13307(c), candidates shall be required to pay, in advance, for the pro rata cost of printing the candidate statement.

Section 6. The amount of pro rata cost is based upon an estimated cost and candidates will be required to pay the actual cost of printing, and the City Clerk is directed to bill candidates for additional actual expenses or refund any excess amount paid depending upon the actual cost of printing of the candidate statement in the voter pamphlet.

Section 7. That in all particulars not recited in this Resolution the method of conducting the recall election shall be conducted, canvassed, and the results declared in substantially the manner provided by law for a regular municipal election.


