#### **DISCUSSION:**

Due to the closure of the Health Services Agency (HSA) Radiology departments in December 2007, various pieces of specialized equipment can no longer be used in the clinic environment. Loma Linda University has expressed need of some equipment for use in its Global Health Institute project. The items to be donated to Loma Linda have token book value and/or are considered technologically obsolete to most domestic healthcare facilities. There are continued annual licensure costs associated with maintaining the equipment in the facility which cannot be eliminated, without certified removal of the equipment. The removal of the equipment by a Loma Linda contractor will meet the requirement and such disposal will have no cost to the County, which may otherwise be borne if not donated.

The Loma Linda Global Health Institute web site states, "We provide humanitarian service through people, programs, and facilities. We promote healthful living and respond to the therapeutic and rehabilitative needs of people. We seek to enhance the quality of life for individuals in local, regional, national, and world communities."

Transfer of the surplus items (list attached) to the Loma Linda Global Health Institute (Loma Linda) will reduce the amount of surplus goods at HSA and assist both HSA and Loma Linda in meeting their mission to respond to the therapeutic and rehabilitative needs of people.

Alternatively, General Services Agency would place the equipment for auction. No individual item of the surplus medical equipment is estimated to have a value in excess of \$1,000. Additionally, there is potentially no market to place many of the items for sale and related expenses could negate any net proceeds.

#### **POLICY ISSUES:**

This action meets the Stanislaus County Board of Supervisors priorities of A Healthy Community, Effective Partnerships, and Efficient Delivery of Public Services by strengthening the county's partnership with this health care provider.
