## DISCUSSION:

In February of each year, the Treasurer-Tax Collector sells, at public auction, real property that has taxes unpaid for a period of five years. After the auction, the Treasurer-Tax Collector performs the following:

- 1. Records a deed for each parcel sold;
- 2. Notifies interested parties if excess proceeds exist;
- Accepts claims for excess proceeds for a period of one year following the recording of the deed; and,
- 4. Subsequently recommends to the Board the distribution of any excess proceeds that have been claimed.

There are four parcels that have excess proceeds from the tax sale on February 25, 2009.

Three have claims for excess proceeds from the February 25, 2009 sale of taxdefaulted property were submitted within one year period and are provided for the Board of Supervisor's approval pursuant to Revenue and Taxation Code Section 4675.

Two of these claims, which have been reviewed by both the Treasurer-Tax Collector and County Counsel, establish the claimant's rights to the excess proceeds and provide documentation. We recommend that the Board of Supervisors authorize the following excess proceeds distribution:


