

**AN ORDINANCE INCREASING EXISTING USED BOOK FEES
COLLECTED AT THE STANISLAUS COUNTY LIBRARY**

THE BOARD OF SUPERVISORS OF THE COUNTY OF STANISLAUS, STATE OF CALIFORNIA, ORDAINS AS FOLLOWS:

Section 1. Used Book Fees to be collected by the Stanislaus County Library are amended as set forth in the Library 2010 Used Book Fee Schedule attached hereto as Exhibit A and incorporated by reference, a copy of which is on file with the Clerk of the Board of Supervisors and is available for public inspection and copying in that office in accordance with the California Public Records Act.



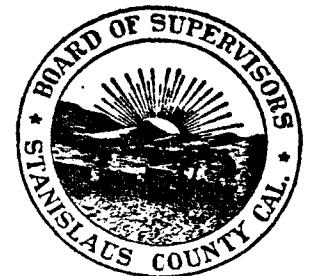
