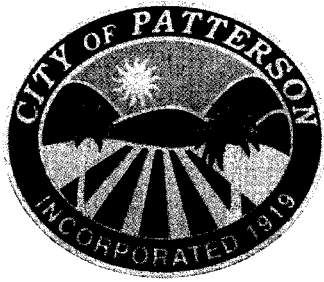

WHEREAS, the City of Patterson will hold an election on November 2, 2010 for the purpose of electing a Mayor and two Councilmembers; and

WHEREAS, the City of Patterson respectively requests that the Stanislaus County Registrar of Voters, Elections Division furnish all other services, facilities, supplies, equipment, etc. necessary for the election; and

WHEREAS, the City of Patterson City Clerk's Office will be responsible for issuing/collecting election information, publishing the Notice of Election and the Nominees for Public Office; and

WHEREAS, the City of Patterson will reimburse the County of Stanislaus for all actual costs for services performed to conduct the municipal election on behalf of the City.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Patterson that it hereby formally requests from the Board of Supervisors of Stanislaus County, California, to consolidate the City of Patterson's Municipal Election with the County's Gubernatorial General Election to be Held on November 2, 2010, Requesting the Services of the Registrar of Voters, Elections Division of the County of Stanislaus to Conduct the Election of Behalf of the City of Patterson.
