# THE BOARD OF SUPERVISORS OF THE COUNTY OF STANISLAUS ORDAINS AS FOLLOWS:

- Section 1. Amend the Stanislaus County Code, Title 11, Chapter 11.08, Section 11.08.020 (No Parking Zone) to add Subsection 534 (Butte Avenue) as follows:
  - "534. Butte Avenue. On the south side of Butte Avenue from its intersection thereof with Crows Landing Road, west to a point 275 feet west of said intersection.
- Section 2. This ordinance shall take effect 30 days from and after the date of its passage, and before the expiration of 15 days after its passage, it shall be published once with the names of the members voting for and against the same in the Modesto Bee, a newspaper in the County of Stanislaus, State of California.


