According to the ShakeOut website, more than 5.4 million Californians are already registered to participate.

**A RESOLUTION OF INTENT TO PARTICIPATE IN THE GREAT CALIFORNIA SHAKEOUT AND  
WORK TOWARD BECOMING A SAFER COMMUNITY**

WHEREAS, the County of Stanislaus recognizes that no community is immune from natural hazards whether it be earthquake, wildfire, flood, winter storms, drought, heat wave, or dam failure and recognizes the importance enhancing its ability to withstand natural hazards as well as the importance of reducing the human suffering, property damage, interruption of public services and economic losses caused by those hazards; and

WHEREAS, major earthquakes pose an ongoing threat to the entire County region; and

WHEREAS, Stanislaus County has a responsibility to promote earthquake preparedness internally as well as with the public and plan appropriately for earthquake-related disasters; and

WHEREAS, the protection of County employees will allow them to facilitate the continuity of government and assist the public following a major earthquake event; and

WHEREAS, community resiliency to earthquakes and other disasters depends on the preparedness levels of all stakeholders in the community – individuals, families, schools, community organizations, faith-based organizations, non-profits, businesses, and government; and

WHEREAS, by participating in The Great California ShakeOut on October 21, 2010, the County of Stanislaus has the opportunity to join and support all Californians in strengthening community and regional resiliency; and
