Approval to Substitute a Subcontractor for Bond Blacktop, Inc. on the ARRA Hughson Sphere Of Influence Cape Seal Project

DISCUSSION:

The ARRA Hughson Sphere of Influence (SOI) Cape Seal project consists of a type II slurry seal over a 3/8 inch polymer modified chip seal. The cape seal will be placed over 5.4 miles of road surfaces creating a smooth, durable, water resistant pavement surface. New striping will be applied on the centerline and edge lines as well as various pavement markings.

The funding for the ARRA Hughson Cape Seal project was provided to the County by Stanislaus Council of Governments (StanCOG) and the City of Hughson to perform projects in and near the City of Hughson's Sphere of Influence. Due to staffing and time constraints at the City, these roads were chosen in conjunction with their Public Works Director as these roads are important to the citizens of Hughson. The County was chosen to receive these funds as the County was better able to design and process the projects through Caltrans under tight deadlines in order for these funds to remain in the region.

All preliminary engineering was done in-house by Public Works Department staff.

The following roads are included in the project:

- Geer Road (Hatch Road to Santa Fe Ave)
- Whitmore Ave (Faith Home Road to Mountain View Road)
- Santa Fe Ave (Hatch Road to Tuolumne River Bridge)

This project is exempt from the California Environmental Quality Act, Class 1, California Code of Regulations, Title 14, #15301 (Existing Facilities).

On February 16, 2010, the Board of Supervisors approved and adopted the plans and specifications for the project and directed the Public Works staff to publish and mail the notice inviting bids.

On March 31, 2010, five (5) sealed bids were received, publicly read and opened. Bond Blacktop, Inc. was deemed the lowest responsible bidder and was awarded the contract on May 4, 2010.

As of late August 2010, work had not begun on this project. County construction staff communicated to Bond Blacktop that it was imperative that work on the ARRA Hughson Cape Seal project get underway to assure the project was delivered before fall or winter weather conditions hampered the quality and progress of the project.

It was brought to the County's attention by Bond Blacktop that their subcontractor Rodgers Construction & Engineering was the reason they had not begun work on the ARRA Hughson SOI Cape Seal project. County staff verified Bond Blacktop's concerns with this subcontractor. If Bond Blacktop were to wait for Rodgers Construction & Engineering to complete the ARRA 2009 Cape Seal project, the ARRA Hughson Cape Seal project would be substantially delayed and in

danger of going into the winter season and possibly suspended until the spring of 2011.

In order to expedite the commencement of the ARRA Hughson Cape Seal project, Bond Blacktop, Inc. has requested pursuant to Section 4107 of the Public Contract Code, to substitute their subcontractor, Rodgers Construction & Engineering, and to perform the work with their own forces. The County has notified Rodgers Construction & Engineering of the substitution request, per the requirements of Section 4107(a)(9) of the Public Contract Code. Rodgers Construction & Engineering has responded that they agree with Bond Blacktop, Inc. to terminate their subcontract for this project. Staff requests approval to substitute Rodgers Construction & Engineering, to assure the successful delivery of the project. The project is currently scheduled to be completed by October 22, 2010.

The Department is also requesting from the Board that they designate the Director of Public Works as the County's duly authorized officer to review and make determinations on all future subcontractor substitution requests for future Public Works projects. This will allow future substitutions requests to be processed in a much shorter time frame and will eliminate the timely process of taking the request to the Board for consideration.

POLICY ISSUES:

The recommended actions are consistent with the Board's priorities of providing A Safe Community, A Healthy Community and A Well Planned Infrastructure System by ensuring that the ARRA Hughson Sphere of Influence (SOI) Cape Seal project proceeds and is completed in a timely manner. The Board should also decide if it should designate the Director of Public Works as the County's duly authorized officer on all future subcontractor substitution requests for Public Works projects.

RE: Request for Subcontractor Substitution

Dear Mr. Saini,

Bond Blacktop requests to remove subcontractor Rodgers Construction & Engineering, Inc. and perform the work with our own forces. Per California Public Contract Code 4107.7, the subcontractor may be removed when the work performed is substantially unsatisfactory and not in substantial accordance with the plans and specifications, or when the subcontractor is substantially delaying or disrupting the progress of the work. Bond Blacktop has notified Rodgers Construction & Engineering, Inc. of this request, and Rodgers Construction & Engineering has agreed to have their subcontract voided for this project.

Bond Blacktop cites the following examples of Rodgers Construction and Engineering Inc.'s work on the current 2009 ARRA Cape Seal Project for the County of Stanislaus, a project similar in cope to this project:

- Insufficient or inadequate traffic control, creating unsafe conditions.
- Leaving roadway with dig outs not fully paved back to grade.
- Insufficient manpower and equipment to complete work on schedule.
- Paving back digouts in lifts of varying/uneven thickness.
- Asphalt spoils left on side of the road and on private property.

The issues listed above have been discussed with Rodgers Construction by both Bond Blacktop and the County of Stanislaus, and Rodgers Construction has failed to maintain an improved level of quality on any of the issues.

In addition, Rodgers Construction was originally scheduled to complete dig out work on the ARRA 2009 Cape Seal project prior to starting the ARRA Hughson SOI project, but has fallen substantially behind and cannot perform the work on the Hughson project as scheduled.

At the request of the County of Stanislaus, Bond Blacktop has previously inquired about the ability of Rodgers Construction to provide a second crew in order to complete the ARRA Hughson SOI project

prior to the rainy season, and Rodgers has stated that they cannot provide the crew and equipment necessary to run both projects concurrently.
