SUBJECT:

Approval to Accept Funding from the U.S. Department of Justice, Office of Community Oriented Policing Services (COPS) Technology Program in the amount of \$300,000

STAFF RECOMMENDATIONS:

- 1. Accept funding from the U.S. Department of Justice, Office of Community Oriented Policing Services (COPS) Technology Program.
- 2. Authorize the Sheriff-Coroner and Chief Executive Officer to sign the Award Document and accept the funding in the amount of \$300,000.
- 3. Direct the Auditor-Controller to increase estimated revenue and appropriations in the amount of \$300,000, according to the budget journal.

FISCAL IMPACT:

Grant revenue of \$300,000 will be received from the U.S. Department of Justice, Office of Community Oriented Policing Services (COPS) Technology Program. This funding will be used to improve the existing infrastructure to our 800 megahertz (MHZ) radio system which is primarily used by special enforcement teams, street crimes units and drug enforcement units to target problematic areas that are high in criminal activity as identified by community policing efforts.

Approval to Accept Funding from the U.S. Department of Justice, Office of Community Oriented Policing Services (COPS) Technology Program in the amount of \$300,000

FISCAL IMPACT (continued):

This is a continuing project and is the foundation for the eventual build out of a county wide public safety radio system. A budget journal increasing appropriations and revenues in the General Fund for the purchase of the equipment is attached. A County Match is not required.

DISCUSSION:

The Stanislaus County Sheriff's Department, upon the approval of this agenda item, will receive grant funding in the amount of \$300,000 from the U.S. Department of Justice, Office of Community Oriented Policing Services (COPS) Technology Program. The funding will be used to improve existing public safety radio equipment. The funds from this grant will be used to purchase four radio transmitters, two radio controllers, networking equipment, antennas, transmission lines and microwave equipment. The costs for the installation of this equipment are also included in the grant. Stanislaus County and its public safety and associated agencies are committed to the development of a radio network that provides the best level of service in support of our citizens and their communities. The overall regional communications between public safety and associated agencies in Stanislaus County are dangerously inadequate. Improvements to day-to-day operational communications within a specific public safety department and the ability to communicate between different public safety departments have been occurring, but more work is needed. Interoperable coverage (the ability to communicate between separate public safety departments) throughout the county continues to be sporadic at best, making it difficult to coordinate crime suppression activities with adjoining jurisdictions and to effectively respond to critical incidents.

Aging equipment needs to be replaced to improve coverage for interoperability; more sites need to be developed and/or upgraded. There have been several recent multi-agency incidents where local public safety responders in Stanislaus County have needed interoperable communications and the current system was inadequate. A recent example occurred two weeks ago. Modesto Police Officers pursued two subjects who were wanted in the robbery of a local pharmacy. The pursuit ended in the county jurisdiction and Deputy Sheriff's responded to assist. A large perimeter was set and they had to search a large field area. To coordinate communications between the County deputies and City police officers a "patch" had to be turned on at the dispatch console. This is an inefficient use of resources and ties up the primary radio communications channels for both agencies making it difficult to dispatch other priority calls for service. Additionally the City radio system has limited coverage outside the City boundaries making communications difficult at times.

In 2001, FEMA stated that one of the most serious threats to face the United States included a large earthquake hitting the San Francisco Bay Area. In the event of a Bay Area earthquake or other disasters, Stanislaus County would be a direct relocation point for hundreds to thousands of people in a time of crisis. A functional and robust public safety radio communications system would be critical. This funding will enhance the existing interoperability channel, expand radio

coverage throughout the county, replace aging equipment, continue progress towards system wide Project 25 compliance (Project 25 is a joint government/industry standards-setting effort to develop technical standards for the next generation of public safety radio communications) and improve the day to day communications and the ability to respond to critical incidents locally and throughout the region. This funding will also help improve the existing infrastructure to our 800 MHZ system, which is primarily used by special enforcement teams, street crimes units and drug enforcement units to target problematic areas that are high in criminal activity as identified by community policing efforts.

The COPS Technology Grant funding is crucial for Stanislaus County and its public safety and associated agencies to be able to provide the best level of service by allowing the partnerships that have been established between agencies to have a operable and interoperable communications system to effectively serve the various communities within the county and our partner agencies in the region.

POLICY ISSUES:

Approval of this item supports the Board's priorities of A Safe Community and Effective Partnerships.

STAFFING IMPACTS:

There is no staffing impact associated with this item. The financial aid will help augment existing resources.

2. The grantee acknowledges its agreement to comply with the Assurances and Certifications forms that were signed as part of its Technology Program application.

3. The funding under this project is for the payment of approved costs for the continued development of technologies and automated systems to assist state, local, and tribal law enforcement agencies in investigating, responding to, and preventing crime. Grant monitoring activities conducted by the COPS Office include site visits, office-based grant reviews, alleged noncompliance reviews, financial and programmatic reporting, and audit resolution.
