# DISCUSSION:

Applications requesting to establish five (5) new Williamson Act Contracts with a combined acreage of approximately 483 acres have been received for 2011. With the exception of one application request, the current applications are for parcels not currently subject to a Williamson Act Contract. These new parcels are being enrolled by owners wishing to take advantage of the property tax benefit applied to restricted parcels. All parcels are zoned A-2-40 (General Agriculture) and meet the parcel size and use requirements necessary to be in compliance with State law and County Uniform Rules. The one exception is the Celeste Gomes application which covers a parcel currently enrolled in a 1972 Williamson Act Contract on which a Notice of Nonrenewal was filed by the previous owners in 2001. The 1972 contract is set to expire on December 31, 2010 and the current owner would like to maintain the parcel in the Williamson Act.

Regulations for the formation of a Williamson Act Contract are set forth in California State Government Code and are listed as follows:

51240. Any city or county may by contract limit the use of agricultural land for the purpose of preserving such land pursuant and subject to the conditions set forth in the contract and in this chapter. A contract may provide for restrictions, terms, and conditions, including payments and fees, more restrictive than or in addition to those required by this chapter.

51241. If such a contract is made with any landowner, the city or county shall offer such a contract under similar terms to every other owner of agricultural land within the agricultural preserve in question. However, except as required by other provisions of this chapter, the provisions of this section shall not be construed as requiring that all contracts affecting land within a preserve be identical, so long as such differences as exist are related to differences in location and characteristics of the land and are pursuant to uniform rules adopted by the county or city.

51242. No city or county may contract with respect to any land pursuant to this chapter unless the land: (a) Is devoted to agricultural use. (b) Is located within an area designated by a city or county as an agricultural preserve.

51243. Every contract shall do both of the following: (a) Provide for the exclusion of uses other than agricultural, and other than those compatible with agricultural uses, for the duration of the contract. (b) Be binding upon, and inure to the benefit of, all successors in interest of the owner. Whenever land under a contract is divided, the owner of any parcel may exercise, independent of any other owner of a portion of the rights of the owner in the original contract, including the right to give notice of nonrenewal and to petition for cancellation. The effect of any such action by the owner of a parcel created by the division of land under contract shall not be imputed to the owners of the remaining parcels and shall have no effect on the contract as it applies to the remaining parcels of the annexation by a city of any land under contract with a county, the city shall succeed to all rights, duties, and powers of the countract.

On January 1, 2004, Assembly Bill 1492 (Laird) took effect and should also be considered when entering property into the Williamson Act. Specifically, AB1492 limits the amount of non-agriculturally related structures on contracted lands which may also include residences.

On November 9, 2010, the Board of Supervisors approved the implementation of SB863 to establish new Williamson Act Contracts including the reduction of property tax benefits by ten percent and a related reduction of the contracts to nine years to be effective beginning calendar year 2011. SB863 creates a program that a county can use when State subvention funding falls to less than half of the county's "actual foregone general fund property tax revenue". The County Assessor is required to apply a new assessed value that reflects the shorter term. The increased valuation is statutorily mandated (under SB863) to be 10% of the difference between (a) the full unrestricted value of the property under Proposition 13 or the market value, and (b) the restricted value of the property under the Williamson Act.

The proposed new contracts are subject to SB863 and, if approved, will be nine year contracts. The property owners applying for new contracts have been provided notice of how implementation of SB863 affects the restricted value of property under the Williamson Act. (See Attachment 2)

The Planning and Community Development Department has reviewed the applications and determined that all uses listed as being on the properties are consistent with agricultural use of the land. Therefore, Department staff recommends approval of all the applications being presented this year for 2011 Williamson Act Contracts.

# POLICY ISSUES:

All of the proposals for Williamson Act Contracts are consistent with policies of the County. The General Plan Land Use and Agricultural Elements both encourage the use of the Williamson Act to help preserve agriculture as the primary industry of the County. The Agricultural Element specifically states that the County shall continue to participate in the Williamson Act program while supporting reasonable measures to strengthen the act and make it more effective. By providing a means to keep property taxes based on an agricultural income level rather than a market value which may be at a level based on speculation of future use, the Williamson Act helps agriculturists remain in production without premature conversion to urban uses. The Williamson Act program is consistent with the Board's goals and priorities of A Strong Agricultural Economy/Heritage.

# NOTICE OF BOARD OF SUPERVISORS DECISION REGARDING A MODIFICATION TO WILLIAMSON ACT CONTRACTS

On Tuesday, November 9, 2010, the Stanislaus County Board of Supervisors at a public hearing took the following actions:

- 1. Conducted a public hearing and approved the implementation of SB863 to establish new Williamson Act contracts including reduction of property tax benefits by ten percent and a related reduction of the term of the contracts to nine years, to be effective beginning calendar year 2011.
- 2. Approved a one-time modification of Stanislaus County's non-renewal procedures to allow landowners to file notices of non-renewal up to February 1, 2011 to be effective in calendar year 2011.
- 3. Directed staff to notify all contracted landowners of the following:
  - (A) The final decision of the Board of Supervisors after the conclusion of the November 9, 2010 public hearing.
  - (B) The landowner's right to prevent the reduction in the term of his or her contract by serving notice of non-renewal as specified by Government Code Section 51245.
- 4. Directed the Assessor, Auditor, Tax Collector, Clerk Recorder and Director of Planning and Community Development to take all necessary steps to implement SB863 including but not limited to recording a notice that states the affected parcel numbers and current owner's names, making the appropriate modifications to all affected properties assessed values, and modifying the Fiscal Year 2011-2012 tax bills to reflect the assessment changes and supplemental fees associated with the reduced tax benefit.

Based on those actions: the **new** Williamson Act Contract you are requesting will be for a 9-year term. This one-year reduction in the term of the contract will be reflected in your Property Tax Bill for 2011 as a reduction in your tax benefit from the Williamson Act. Williamson Act Contracts renew automatically on January 1<sup>st</sup> of each year. SB 863 must be implemented yearly by the County and has a sunset date of January 1, 2015. It is anticipated that all Williamson Act Contracts will return to a 10-year term by 2015, unless further action to modify the Williamson Act program is taken at the State level. Information regarding SB 863 is available at the following web site: <u>http://www.stancounty.com/planning</u> You may also contact the Assessor at (209) 525-6461 to determine the impact of SB 863 to your tax bill.

If after receiving this notice you desire to keep your property <u>out</u> of the Williamson Act, please contact the Planning Department at (209) 525-6330 (<u>planning@stancounty.com</u>) by December 13, 2010. Your application for a new Williamson Act Contract is scheduled to be considered as a consent calendar item by the Board of Supervisors on December 14, 2010. Your participation at the Board of Supervisors meeting is not required. Consent calendar items are recommended for "routine" approval and are not discussed unless someone requests the item be removed from "consent". The Board of Supervisors meeting is conducted in the basement level Chambers located at 1010 10<sup>th</sup> Street, Modesto.
