Approval to Introduce and Waive the First Reading of an Ordinance to Amend Section 3.08.290 of the Stanislaus County Code Relating to Hiring Preference for Veterans

DISCUSSION:

Stanislaus County is committed to providing employment assistance to veterans who served full-time in the United States Armed Forces in a time of national military emergency, or whose units were ordered to active duty by presidential order in a time of state military emergency, or who have served in any military expedition of the Armed Forces. This commitment is demonstrated with the Veterans Preference Points policy. The policy grants an eligible applicant who has received a passing score in an open entry level examination in an eligible classification credit of additional grade points to the final examination score. Eligible veterans are granted five additional grade points.

The intent of the policy is to provide additional points to veterans who have served during a war or in a campaign or expedition. Currently, the ordinance lists the specific military efforts of which veterans must have participated in to be eligible for veterans' preference points and does not include Operation Iraqi Freedom. In order to ensure that the intent of the policy is effectively met, it is recommended that Stanislaus County Code Sections 3.08.290(B)(1) and 3.08.290(B)(2) be modified, as detailed in the attached documents, to maintain consistency with United States Code.

This modification will ensure that County Code is consistently in alignment with United States Code without requiring the ordinance to be modified as United States Code is updated to recognize new military efforts.

POLICY ISSUES:

The Board of Supervisors should determine if approval of staff's recommendation meets its stated priority to promote the efficient delivery of public services.

STAFFING IMPACT:

There are no staffing impacts associated with this item. Staff will continue to provide support to veterans in the processing of veteran preference point applications.

ORDINANCE NO. C.S.

AN ORDINANCE AMENDING CHAPTER 3.08 OF THE STANISLAUS COUNTY CODE RELATING TO HIRING PREFERENCE FOR VETERANS

THE BOARD OF SUPERVISORS OF THE COUNTY OF STANISLAUS, STATE OF CALIFORNIA, DO ORDAIN AS FOLLOWS:

Section 1. Subsection (B)(1) of Section 3.08.290 of the Stanislaus County Code is amended to read as follows:

"For purposes of this chapter, the term "veteran" is defined by United States Code Title 5, Part III, Subpart A, Chapter 21, Section 2108 (1)."

Section 2. Subsection (B)(2) of Section 3.08.290 of the Stanislaus County Code is amended to read as follows:

"For the purpose of this chapter, the term "disabled veteran" is defined by United States Code Title 5, Part III, Subpart A, Chapter 21, Section 2108 (2)."

Section 3. This ordinance shall take effect thirty (30) days from and after the date of its passage and before the expiration of fifteen (15) days after its passage it shall be published once, with the names of the members voting for and against the same, in the Modesto Bee, a newspaper published in the County of Stanislaus, State of California.
