FISCAL IMPACT: (Continued)

Failure to proceed with this project would incur fines from the California Department of Public Health of \$156,200, as of March 1, 2011, plus \$200 per day a day until repairs are completed. At this time, \$5,000 is required for reproduction costs, advertisement costs and other agency costs associated with the bid process.

DISCUSSION:

Located in Western Stanislaus County, Frank Raines Regional Park is a recreational destination focused on off-highway vehicle use, hiking, camping and other outdoor activities. In January, 2007, the California Department of Health Services (CDPH) issued Compliance Order No. 03-10-07CO-011 requiring the County to make significant upgrades to the water supply system at Frank Raines Regional Park, because of Bacterial contamination consistently found in water testing at this location. The Department of Parks and Recreation began working on a detailed response to the CDPH Compliance Order which included an engineering study to outline options to clean the water, a sanitary survey of the water source and implementation of a pilot filtration program to investigate potential solutions to the water contamination problems in Frank Raines Regional Park.

This project could be constructed in three phases with the baseline construction phase and two alternate or additional phases, depending upon the outcome of the bid process. The baseline project includes upgrades to the existing well, new water distribution main lines and a treatment/filtration system with an estimated cost of approximately \$610,000. Alternate 1 includes new water services at the campground area campsites, with an estimated cost of approximately \$75,000. Alternate 2 includes new electrical system and services to the campsites with an estimated cost of approximately \$110,000. One, two, or all three of the phases could be built if the construction bids do not exceed the total budget.

On March 16, 2010, the Board authorized an agreement with Psomas, an engineering firm, for the amount of \$209,283 plus a contingency of \$31,392 for a total authorization of \$240,675 for Master Planning, Design and Construction Support Services for upgrades to the Frank Raines Regional Park Water Filtration (Potable and Non-Potable).

At this time, Public Works, in conjunction with the Department of Parks and Recreation, is returning to the Board for approval of plans and specifications for upgrades to the Frank Raines Regional Park Water Filtration System (Potable and Non-Potable). Public Works is also requesting approval to issue a notice inviting bids for the construction of the project and approval to open and evaluate bids and return to the Board to recommend a contract award.
