Legislative Position Paper

Bill Number: SB 407 (Cannella)

Proposed Position: Support

Bill Summary: SB 407 implements changes to Labor Code section 3370 which currently applies to State Prisoners. This bill will expand this section of the code to include Jail Inmate labor. Temporary Disability benefits will not be paid while a prisoner or inmate is incarcerated. The amount of Temporary Disability and Permanent Disability benefits will not exceed the minimum limits set forth in Labor Code Section 4453. The occupation for an inmate will be limited to a laborer. The Sheriff's Office will have medical control over the inmate allowing Jail medical to provide treatment or the Sheriff may take the inmate out of the facility for treatment. Medical treatment will continue to be paid by the County's Workers' Compensation program. Labor Code Section 4453 would be amended to change the minimum Temporary Disability benefit rate to the lesser of \$189 a week or actual wages. This bill also changes the Labor Code to consider Jail Inmates the same as State Prisoners in that no Temporary Disability benefits will be paid while an Inmate or Prisoner is incarcerated or re-incarcerated. If the injury causes permanent disability the benefit amount will be based on a "job classification" of a laborer which will result in a lower permanent disability benefit.

Pertinent Issues/Analysis: The County currently provides Workers' Compensation coverage to inmates and volunteers while working on behalf of the County. The Labor Code mandates that Temporary Disability benefits payments of two-thirds an "employee's" average weekly wage subject to a minimum of \$189 a week even if the individual in question has no proof of earned wage history.
