DISCUSSION:

The Stanislaus Child Development Local Planning Council (LPC) was established by the Board of Supervisors pursuant to the State of California Assembly Bill (AB) 1542 & California Education Code 8499 on July 28, 1998 to provide a forum for the identification of local priorities for child care and the development of policies to meet the needs identified within those priorities.

California Education Code 8499 requires each local planning council by May 30th of each year, upon approval by the County Board of Supervisors and the County Superintendent of Schools, to submit to the California Department of Education (CDE) any changes to the local priorities it identifies that reflect all child care needs in the county. Priority levels are reported to the CDE by program and zip code, and are based on percentages of eligible children as well as specific numbers of children not receiving program services, with "Priority 1" representing the level with the greatest need. The priority information that is provided in the report assists the CDE in determining which zip codes should receive funding made available through CDE Request for Funding Applications.

The attached Stanislaus Child Development Local Planning Council 2011-2012 Priorities Report reflects the following changes to the priorities in Stanislaus County based on the 2010 Census data:

- <u>General Child Care and Development Program:</u> No changes identified at this time
- <u>State Preschool Child Care and Development Program</u>: Zip Code 95328 changed from Priority 2 to Priority 1 Zip Code 95387 changed from Priority 3 to Priority 2

Priorities are a part of the mandated requirements for the LPC. The priorities are submitted for California Department of Education (CDE) use. In the event that funding is made available through a CDE Request for Funding Applications (RFA), the LPC priorities would be used to assist CDE in determining which zip codes should receive funding. For example, using the 2011 priorities for State Preschool Child Care Development programs if funding were to be released all areas of the county are listed as Priority 1 with the exception of 95313 (Crows Landing) and 95387 (Westley) which are listed as Priority 2 and 95319 (Empire), 95323 (Hickman), and 95385 (Vernalis) which are listed as Priority 3.

The Agency requests the Board of Supervisors to approve the Stanislaus Child Development Local Planning Council 2011-2012 Report.

As part of the Local Planning Council (LPC) annual requirements, the LPC reviews the need and supply data regarding subsidized child care slots in the county. The LPC determined that the 2010 Priorities as submitted to California Department of Education (CDE) for the General Child Care and Development Program that serves infants, preschool and school age children are still valid and that no changes are needed at this time. However, based on the 2010 Census data it was determined that the State Preschool Child Care Development Priorities needed to be updated. The zip code 95328 has moved from a Priority 2 to a Priority 1 and zip code 95387 has moved from a Priority 3 to a Priority 2.

The Priorities Report was approved by the SCDLPC at the May 6, 2011 Executive Committee meeting. The SCDLPC has obtained the approval of the Superintendant of Schools. The SCDLPC requests to have the Priorities Report placed on an upcoming Stanislaus County Board of Supervisors Agenda for approval before May 30th if possible. Once approval is granted the SCDLPC will submit the approved document to California Department of Education (CDE).
