#### **STAFF RECOMMENDATIONS (Continued):**

- Authorize the HSA Managing Director, her designee or successor, to negotiate and sign individual amendments to the agreements, not to exceed \$75,000 per agreement.
- 4. Authorize the HSA Managing Director to maintain a Non-Contracted Medical Services policy and procedure for the Medically Indigent Adult program as set forth in this agenda item.

#### **DISCUSSION:**

The attached list of Independent and Personal Services Contractors includes direct medical providers, and other contractors to fulfill the mission of the HSA in providing medical care to County Indigents and other County patients, and services to fulfill the County's public health mandates and other grant funded responsibilities.

Consistent with the policy adopted by the Board of Supervisors on January 24, 2006, and amended on March 22, 2011, the attached list includes those contractors for whom Board approval is required as the cumulative amount estimated to be paid to these contractors by the HSA from the period July 1, 2009 through June 30, 2012 will be more than \$100,000, as well as those that are required to be reported to the Board of Supervisors, as the cumulative amount for that period is in excess of \$50,000.

The total amount of contracts over \$100,000 cumulatively, to be approved by the Board of Supervisors through this agenda item is \$12,543,272 for Fiscal Year 2011-2012.

Specifically regarding the Medically Indigent Adult (MIA) program, the HSA secures many contractual agreements for the services not provided directly by HSA's Clinic and Ancillary division, such as cardiology and radiology, and as illustrated on the attached list. Since the MIA program is often arranging medical care for which time is of the essence, it is not always possible to use a provider already under contract and as a result circumstances exist that make it infeasible or impossible to secure written contractual agreements for every covered service; however, these circumstances in no way relieve the County of the obligation to arrange for and pay for those services required under the Welfare and Institutions Code Section 17000. Such circumstances generally include emergency services, shortage of provider capacity, unwillingness by providers to commit to a written contract to serve the indigent population, and locum tenens (short-term substitute physician). For perspective, staff reviewed Fiscal Year 2009/2010 expenditures and noted that 5.3% of healthcare expenditures needed to be secured in instances where there was not a written contract in place. Regardless of the existence of a written contract or Memorandum of Understanding, all healthcare providers submit claims for reimbursement using nationally recognized procedural code and/or services rendered descriptions, and the program achieves a discounted rate of reimbursement in almost every instance, including those not supported by a written

agreement. In the past two years, staff reported that claims were paid without achieving a discount on 13 claims out of more than 150,000 total claims. HSA staff has worked with both the County Counsel's office and with the General Services Agency to develop an administrative policy and procedure which acknowledges the important needs of the HSA and the circumstances of the MIA program and which provides for alternative efforts to assure appropriateness of services and reimbursement, provider credentials and the existence of industry standard liability coverage.

#### **POLICY ISSUES:**

Approval of these recommendations supports the Board's priorities of A Healthy Community, Effective Partnerships, and Efficient Delivery of Public Services through effectively securing available, needed resources in a planned, organized and compliant manner.
