#### **DISCUSSION:**

The California Partnership for the San Joaquin Valley, (the Partnership) established in 2005 and represented by all 8 counties of the San Joaquin Valley serves as the regional leader in Advanced Communication Services and Information Technology in the Central Valley. One of the initiatives undertaken by the Partnership is the expansion of high-speed internet access, generically referred to as "broadband", to unserved and underserved communities throughout the Valley.

In 2010, 30% of all Californians, 51% of low-income households, 50% of Latino families, 45% of people with disabilities and 49% of Central Valley households were not connected to the internet with broadband, leaving more than 10 million Californians without high-speed internet access at home. The Partnership believes that broadband is essential 21st century infrastructure in a digital world and global economy, and is vital to the economic prosperity and quality of life for residents in Stanislaus County and throughout California.

California is home to a wellspring of innovation that has given rise to the evolution of broadband and other information technologies, but Californians' adoption and use of broadband technology is only approximately equivalent to the national average. The use of the internet connected through a broadband infrastructure can save both time and money for residents while helping them bridge the economic divide. In our 21st century learning environment, high-speed internet connectivity will help students obtain the highest-quality education possible. The availability of computing devices both at school and at home are critical teaching and learning tools for academic achievement.

The Partnership also notes that broadband is a strategic "green" technology that decreases greenhouse gas emissions and dependence on foreign oil by enabling e-government and the provision of more services online.

SB 1040 authorizes the extension and expansion of the California Advanced Services Fund (CASF) established by the California Public Utilities Commission (CPUC) to promote and support broadband infrastructure deployment to unserved and underserved communities. If approved, the proposed resolution would formally support the Partnership as the Regional Broadband Consortium and the deployment of broadband infrastructure to unserved and underserved communities.

### **POLICY ISSUES:**

The Board of Supervisors is asked to consider the adoption of a resolution supporting the implementation of SB 1040 which authorizes the extension and expansion of the California Advanced Services Fund (CASF). Approval of this

resolution would lend the County's support to a proposed project that, when implemented will support the Board's priorities of A Well Planned Infrastructure, Efficient Delivery of Public Services, and Effective Partnerships through the establishment of new broadband infrastructure and the expansion of existing broadband infrastructure to unserved and underserved communities in Stanislaus County.
