FISCAL IMPACT:

For Federal Fiscal Year 2011, \$15.5 million has been appropriated to the State of California for the Edward Byrne Memorial Justice Assistance Grant (JAG) that is administered by the Bureau of Justice Assistance (BJA), U.S. Department of Justice. The JAG program allows states, tribes and local governments to support a broad range of activities to prevent and control crime based on their own local needs and conditions. The County has previously received funding from the Local Law Enforcement Block Grant (LLEBG) program since 1996 which has been used to fund positions and purchase (continued on page 2)

equipment. The LLEBG funds are now included in the JAG program.

The grant funding will provide \$186,199 in Federal funding to Stanislaus County. The funding will be shared between the Stanislaus County Sheriff, Probation and the City of Modesto. This represents a decrease of \$23,302 for the County and \$26,315 for the City of Modesto from the 2010 JAG grant of \$235,816 awarded by BJA and approved by the Board of Supervisors on June 8, 2010. The City of Modesto received \$157,828 and \$77,988 was shared between the Probation and Sheriff's Departments. A County match is not required.

DISCUSSION:

Funding in the amount of \$186,199 is available in 2011 from the JAG program for use in Stanislaus County. Awards are made in the first fiscal year of the appropriation and may be expended during the following three years for a total of four years. This is the seventh year that the JAG program will be available. Funding received from the 2005, 2006, 2007, 2008, 2009 and 2010 JAG have been utilized to fund positions that were previously funded through the Local Law Enforcement Block Grant.

Previously, funding received through the LLEBG was utilized to fund one full-time Deputy Probation Officer for the Domestic Violence Program and one full-time Deputy Sheriff to provide community policing services for the South Modesto area surrounding the Shackleford School area and one-half of a Deputy Sheriff position to provide a School Resource Officer on site at the Tuolumne Elementary School.

For the third time in the six years the county has been receiving Justice Assistance Grant (JAG) funds from the Department of Justice (DOJ), the County and the City of Modesto must file jointly due to what the DOJ terms Disparate Allocation. According to the DOJ this occurs "when a city or municipality is scheduled to receive one and one-half times (150 percent) more than a county with concurrent jurisdiction, while that county bears more than 50 percent of the costs associated with prosecution or incarceration of the municipality's Part 1 violent crime. When this occurs, the county and cities must identify a fiscal agent and submit a joint application for the total eligible amount." The Stanislaus County Sheriff's Department has been identified as the fiscal agent and

will submit a joint application with the City of Modesto Police Department for the total grant amount of \$186,199 to be split among three agencies as described in the memorandum of agreement. The DOJ allocation of funds provides the county with \$54,686 and the city \$131,513. The grant also allows for an administrative fee of up to 10% to be charged by the fiscal agent. The Sheriff's Department will be charging a 3% administrative fee. The application of the administrative fee will result in the county receiving \$58,631 and the city receiving \$127,568.

The Modesto Police Department will use its allocated share of \$127,568 to purchase personal video recording devices and an additional computer server to store the video. The JAG funds of \$39,784 for the Sheriff and \$13,261 for Probation will assist both departments with the funding of one-third of the Deputy Sheriff position assigned as a School Resource Officer for Tuolumne Elementary School and one-sixth of a Deputy Probation Officer for the Domestic Violence Program.

If the Board of Supervisors concurs, an application will be finalized with the Bureau of Justice Assistance for this funding. The Sheriff's Department recommends the County take advantage of this funding opportunity and approve the staff recommendations to accept the funding from the U.S. Department of Justice, Bureau of Justice Assistance.

The Sheriff recommends that the Board of Supervisors approve the attached Memorandum of Agreement between the County of Stanislaus and the City of Modesto for the Justice Assistance Grant Program Award and authorize the Chairman of the Board of Supervisors to sign the Memorandum of Agreement approving the joint application by the Stanislaus County Sheriff's Department and the City of Modesto Police Department.

POLICY ISSUES:

Board approval to apply for this entitlement funding is necessary prior to the obligations of program funds. Utilization of this funding will enhance criminal justice processes in our community, consistent with the Board's stated priorities of ensuring A Safe Community and Effective Partnerships.

STAFFING IMPACT:

There are no recommendations to modify the Salary and Position Allocation Resolution by this

MEMORANDUM OF AGREEMENT BETWEEN THE COUNTY OF STANISLAUS AND THE CITY OF MODESTO FOR THE EDWARD BYRNE MEMORIAL JUSTICE ASSISTANCE GRANT (JAG) FORMULA PROGRAM: LOCAL SOLICITATION AWARD

This Agreement is made and entered into this <u>5th</u> of July, 2011, by and between The County of Stanislaus, hereinafter referred to as COUNTY, and the City of Modesto, hereinafter referred to as CITY, to distribute the above referenced grant funds:

WHEREAS, the COUNTY and the CITY, in performing governmental functions or in paying for the performance of governmental functions hereunder, shall make that performance or those payments from current revenues legally available to that party, and

WHEREAS, the COUNTY and the CITY find that the performance of this Agreement is in the best interests of both parties, that the undertaking will benefit the public, and that the division of costs fairly compensates the performing party for the services or functions under this Agreement, and

WHEREAS, the CITY's share of the JAG award that was awarded to both the COUNTY and CITY for the Equipment Offset is \$127,568 (\$131,513 less 3% Administrative Fee of \$3,945 to be paid to the County), and

WHEREAS, the COUNTY and the CITY believe it to be in their best interests to reallocate the JAG funds as set forth above.

NOW THEREFORE, the COUNTY and CITY agree as follows:

Section 1.

COUNTY agrees CITY'S share of the award is a total of \$127,568 of JAG funds.

Section 2.

CITY agrees to use \$127,568 to purchase lapel cameras with audio and video recording capabilities and an additional computer server to store the videos.

Section 3.

The CITY agrees to provide the COUNTY a quarterly financial and programmatic report not later than fifteen (15) calendar days after the end of the quarter. This will allow the COUNTY to submit the final report on the grant in the required thirty (30) calendar days after the end of each quarter.

The Programmatic and Financial Reporting Periods and Due Dates to the County are as follows:

October-December	January 15
January-March	April 15
April-June	July 15
July-September	October 15

Section 4.

Nothing in the performance of this Agreement shall impose any liability for claims against COUNTY other than claims for which liability may be imposed by the Tort Claims Act.

Section 5.

Nothing in the performance of this Agreement shall impose any liability for claims against CITY other than claims for which liability may be imposed by the Tort Claims Act.

Section 6.

Each party to this Agreement will be responsible for its own actions in providing services under this Agreement and shall not be liable for any civil liability that may arise from the furnishing of the services by the other party.

Section 7.

The parties to this Agreement do not intend for any third party to obtain a right by virtue of this Agreement.

Section 8.

By entering into this Agreement, the parties do not intend to create any obligations express or implied other than those set out herein; further, this Agreement shall not create any rights in any party not a signatory hereto.

The signature of the parties below designate acceptance of the terms of this Agreement and shall be binding upon the parties upon the effective date of the Agreement.

IN WITNESS WHEREOF, the City of Modesto, a municipal corporation, has authorized the execution of this Agreement in duplicate by its City Manager and attestation by its City Clerk under authority of Resolution No. 2011-232__, adopted by the Council of the City of Modesto on the $5_$ day of Ju1y2011, and the County of Stanislaus has caused this Agreement to be duly executed.

DESCRIPTION:

Consider approving a Memorandum of Agreement between the County of Stanislaus and the City of Modesto for a joint application for funding in the amount of \$186,199 through the Edward Byrne Justice Assistance Grant (JAG) Formula Program. (Funding Source: Special Revenue Grant)

FISCAL IMPACT:

The Modesto Police Department is considered a "disparate" allocation under the terms of this grant because the City is eligible to receive one and one-half times more than the County (150% more than the County with concurrent jurisdiction). Jurisdictions certified as disparate must identify a fiscal agent that will submit a single, joint application for the total eligible allocation. Therefore, the Modesto Police Department and Stanislaus County are required to submit a joint application for the total eligible allocation of \$186,199.

Under the grant, the Modesto Police Department is eligible to apply for \$131,513 and Stanislaus County is eligible to apply for \$54,686. Stanislaus County will be the fiscal agent for this grant. The County will charge the City a three percent (3%) administrative fee in the amount of \$3,945 to cover the reporting costs associated with the grant. The administrative fee reduces the City's total projected grant award to \$127,568 (\$131,513 less the 3% administrative fee of \$3,945).

Recommended distribution of the 2011 JAG funds is as follows:

Probation	\$ 13,261
Sheriff	\$ 39,784
Sheriff (Administrative Fee)	\$ 5,586
Modesto Police Department	\$127,568

There is no match required for this grant. Awards are made in the first fiscal year of the appropriation and may be expended during the following three years for a total of four years.

BACKGROUND:

On June 9, 2011, the U.S. Department of Justice announced that the Office of Justice Programs' (OJP) Bureau of Justice Assistance (BJA) was seeking applications for funding under the Edward Byrne Memorial Justice Assistance Grant (JAG) Program.

The allocation of JAG grants is based on a formula of population and violent crime statistics, in combination with a minimum allocation to ensure that each state and territory receives an appropriate share of funding. The JAG program allows states, tribes and local governments to support a broad range of activities to prevent and control crime based on their own local needs and conditions. JAG blends in the Local Law Enforcement Block Grant Program to provide agencies with the flexibility to prioritize and place justice funds where they are needed most. Funds through the Local Law Enforcement Block Grant are no longer available.

Beginning in 2009, the formula calculation for the local portion of the JAG statute changed significantly as a result of final implementation of the JAG statute. The statute, 42 USC 3755(d)(2)(B), specifies that for Fiscal Years 2005 through 2008, local government allocations would follow the Local Law Enforcement Block Grant (LLEBG) formula. Pursuant to the statute, however, calculations for FY 2009 (and subsequent JAG calculations) require that local governments must have submitted to the FBI at least three years of Uniform Crime Report (UCR) data during the most-recent ten-year period for which UCR data are available (here, 1999-2008) in order to be eligible.

The City of Modesto will use its allocation to purchase personal recording devices and an additional computer server to store the videos. The Stanislaus County Sheriff's Department will disburse its allocated funding of \$54,686 between the Probation Department and Sheriff's Operations Division. The Stanislaus County Sheriff's Department funding will support a portion of a Deputy Sheriff position assigned as a School Resource Officer for the Tuolumne Elementary School. The Probation Department plans to use their \$17,988 to fund a portion of a Deputy Probation Officer for the Domestic Violence Program. Both positions would be funded for a one-year period.

The grant requires that a trust fund must be established for fund deposits. The trust fund may or may not be an interest-bearing account. Funds from any award cannot be comingled with funds from any other source.

The Memorandum of Agreement states that the City agrees to provide the County a quarterly financial and programmatic report not later than fifteen calendar days after the end of the quarter.

The project start period is July 1, 2011, and there is a statutory four-year period within which to spend the funds. The signed Memorandum of Agreement is required for the application which is due June 21, 2011.

COMMITTEE RECOMMENDATION:

This item was not presented to a Council Committee. This item is scheduled to go to the Board of Supervisors on July 12, 2011, for approval of the County of Stanislaus as the fiscal agent.
