#### FISCAL IMPACT:

On December 21, 2010 the Board of Supervisors approved the project's initial financing plan. The original financing plan for the construction of a 60 bed facility was originally estimated not to exceed \$24,232,528. The Financing Plan includes State funding of \$18 million towards construction, funded through a lease-revenue bond financing plan. The primary sources of cash match the County has committed includes funding of \$1,725,000 from Public Facility Fees (PFF), funding of \$2,732,528 from the Criminal Justice Facility Fund, and a non-cash match from land valued at \$1,775,000 at the site where the new facility will be constructed, for a total match of \$6,232,528.

Following the projects design and approvals by the State Corrections Standards Authority, State Public Works Board, the State Department of Finance and after receiving interim State project funding from the Pooled Monies Investment Board, the Board of Supervisors authorized receipt of construction bids on July 12, 2011. Bids were received on August 24, 2011. A conditional award of a construction contract conditioned upon State approval to proceed with the construction of the Stanislaus County Juvenile Commitment Center Project to Roebbelen Contracting, Inc. of El Dorado Hills, California for the lump sum amount not to exceed \$14,983,000 on September 20, 2011. The State of California has officially authorized the Project to proceed to construction and the construction contract has been fully executed.

The Board of Supervisors also authorized an increase in appropriations of \$18,514,104 and estimated revenue of \$16,481,300 for the construction phase of the project to provide full project funding revised based on the final construction contract amount. The revised project funding sources and expenses are outlined on the chart below:

This Board of Supervisors action fulfills a requirement by the State of California for the merger of two existing lots that remained from the site's former State Hospital use prior to the County's acquisition of the property. There is no additional fiscal impact of this action.

#### **DISCUSSION:**

The Juvenile Commitment Center project is a State Senate Bill 81 Local Youthful Offender Rehabilitative Facility project, financed jointly by State lease revenue bonds and matching funds from Stanislaus County. The project is subject to the requirements of the State Corrections Standards Authority and review by and approval of the State Fire Marshal. During the design review and State Fire Marshall review process, the State Fire Marshall conditioned approval of the project upon merger of two existing lots (see Exhibit "C", attached) identified as Parcel 1 and Parcel 2 into a single lot.

Parcels 1 and 2 are remnants of the property's former ownership by the State of California and use as the Hammond State Hospital site until it was split in 1970 between Stanislaus County and Yosemite Community College District. The merger of Parcels 1 and 2 only affect the Stanislaus County property and the site of the Juvenile Commitment Center project *not* the nearby Junior College.

Approval of this action will authorize the County's Chief Operations Officer to sign and record the attached legal descriptions before and after the lot merger and the lot merger plat.

#### **STAFFING IMPACT:**

There is no staffing impact as a result of this action. Existing County Chief Executive Office-Capital Projects staff and Probation Department staff continue to manage the projects toward its successful completion.

#### **POLICY:**

This action satisfies the requirements of the State of California for continued development of the Juvenile Commitment Center project pursuant to the Board's priority of providing efficient delivery of public services.




