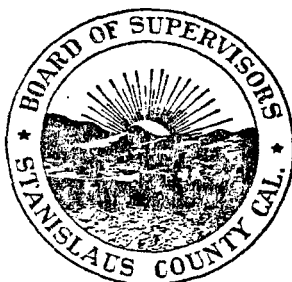
AN ORDINANCE AMENDING STANISLAUS COUNTY CODE, SECTION 11.08.020  
RELATING TO NO PARKING ZONE ON EMERALD AVENUE,  
IN THE MODESTO AREA

**THE BOARD OF SUPERVISORS OF THE COUNTY OF STANISLAUS ORDAINS AS  
FOLLOWS:**

- Section 1. Amend the Stanislaus County Code, Title 11, Chapter 11.08, Section 11.08.020 (No Parking Zone) to add Subsection 538 (Emerald Avenue) as follows:
- “538 Emerald Avenue. On the west side of Emerald Avenue from Kansas Avenue to Woodland Avenue.”
- Section 2. Amend the Stanislaus County Code, Title 11, Chapter 11.08, Section 11.08.020 (No Parking Zone) to repeal Subsections; 213, 246, 255, 357, and 410 (Emerald Avenue), Modesto Area.
- Section 3. This ordinance shall take effect 30 days from and after the date of its passage, and before the expiration of 15 days after its passage, it shall be published once with the names of the members voting for and against the same in the Modesto Bee, a newspaper in the County of Stanislaus, State of California.

Upon motion of Supervisor De Martini, seconded by Supervisor O'Brien, the foregoing ordinance as passed and adopted at a regular meeting of the Board of Supervisors of the County of Stanislaus, State of California, this 8th day of November, 2011, by the following called vote.

AN ORDINANCE AMENDING STANISLAUS COUNTY CODE, SECTION 11.08.020 RELATING TO NO PARKING ZONE ON EMERALD AVENUE, IN THE MODESTO AREA THE BOARD OF SUPERVISORS OF THE COUNTY OF STANISLAUS ORDAINS AS FOLLOWS:

Section 1. Amend the Stanislaus County Code, Title 11, Chapter 11.08, Section 11.08.020 (No Parking Zone) to add Sub-section 538 (Emerald Avenue) as follows: "538 Emerald Avenue. On the west side of Emerald Avenue from Kansas Avenue to Woodland Avenue."

Section 2. Amend the Stanislaus County Code, Title 11, Chapter 11.08, Section 11.08.020 (No Parking Zone) to repeal Sub-sections; 213, 246, 255, 357, and 410 (Emerald Avenue), Modesto Area.

Section 3. This ordinance shall take effect 30 days from and after the date of its passage, and before the expiration of 15 days after its passage, it shall be published once with the names of the members voting for and against the same in the Modesto Bee, a newspaper in the County of Stanislaus, State of California.
