Approval to Summarily Vacate a Portion of the Southeast End of Rancheria Drive, Located East of the City of Oakdale

DISCUSSION:

Curtis Lineberger, a home owner, has requested the abandonment of the portion of the southeast end of Rancheria Drive, located east of the City of Oakdale. This portion of road is at the end of a cul-de-sac and is not maintained for road purposes. Public Works has an easement for road way purposes but has determined that this portion of Rancheria Drive is excess right-of-way and is not needed for future road purposes. Control of the abandoned area will revert back to the adjacent land owners who currently own fee title of said property.

The utility companies, AT&T, Pacific Gas and Electric, along with Oakdale Irrigation District may have facilities within the abandonment area and a Public Utility Easement will be retained to protect their interests.

POLICY ISSUES:

The recommended actions are consistent with the Board's priority of A Well Planned Infrastructure System by removing any excess right-of-way that is not needed for road way purposes, therefore removing any liability. Street and Highways Code 8334(a) states that the legislative body of a local agency may summarily vacate excess right-of-way of a street or highway not required for street or highway purposes.



APPROVAL TO SUMMARILY VACATE A PORTION OF THE SOUTHEAST END OF RANCHERIA DRIVE, LOCATED EAST OF THE CITY OF OAKDALE

BE IT RESOLVED that the Board of Supervisors, of the County of Stanislaus, State of California, hereby finds and determines as follows:

1. The vacation of the excess street right-of-way described herein below in made under Chapter 4, of Part 3, of Division 9 of the California Streets and Highways Code (Sections 8334(a) and 8335).

2. The excess street right-of-way to be vacated is a portion of Rancheria Drive bordered by the northerly and westerly right-of-way and property shown as parcels 17 & 18 from that certain subdivision map entitled "Orange Blossom Hills" filed for record in Book 28 of maps, at Page 4, Stanislaus County Records, and more particularly described in Exhibit "A" attached hereto and shown on the precise map attached hereto as Exhibit "B".

3. The excess street right-of-way hereby is not required for highway purposes. Furthermore the area requested would provide required setback for site improvements to adjacent property. The existing in-place utilities will be protected by an easement for their benefit.

4. That from and after the date this resolution is recorded by the County, the vacated excess street right-of-way herein described no longer constitutes a street, or highway.

Also in accordance with Section 8336(a) of the Street and Highway Code:

The Stanislaus County Clerk of the Board shall cause a certified copy of this resolution of vacation, attested by the Clerk under seal, to be recorded without acknowledgement, certificate of acknowledgement, or further proof in the Office of the Recorded of this County, in which the property is located. No fee shall be charged for recordation.
