DISCUSSION:

On November 1, 2011 the Board of Supervisors approved the First Quarter Financial Report for Fiscal Year 2011-2012. Included in this action was a request from the Community Services Agency to fund an Account Clerk III in the Auditor-Controller's Office Accounts Payable division at an annual rate of \$74,250.

The request to fund an Account Clerk III is to ensure that vendor transactions specific to Community Services Agency are processed with a quicker turnaround time. The Auditor-Controller's Office does not have the capacity to meet the needs of the Community Services Agency with the current level of employees in the Accounts Payable division. Funding for this additional Account Clerk III is anticipated to be available for the next few years.

The budget for the Auditor-Controller's office will be balanced as the increase in the salaries and benefits appropriations will be offset by the revenue from the Community Services Agency.

POLICY ISSUES:

This action is consistent with the Board of Supervisors' priorities of promoting Efficient Delivery of Public Services.

STAFFING IMPACT:

The Auditor-Controller's Office is requesting to fund Account Clerk III position number 3486 that is currently unfunded in the Department.
