Approval to Accept the Various Portions of Stoddard Road, Pirrone Road and Dale Road as Offered by the Modesto City Schools District, Being a Part of the Gregori High School Project

## DISCUSSION:

As part of the Joseph Gregori High School project, the Modesto City Schools District, working with Stanislaus County has completed the street improvements on Stoddard Road, Pirrone Road and Dale Road as required by the approved construction plans. This includes right-of-way for the creation of Pirrone Road, improvements along the east side of Stoddard Road, a public utility easement along the west right-of-way of Dale Road, and the signalization of the intersection of Pirrone Road and south entrance to Gregori High School.

Stanislaus County has jurisdiction over the existing right-of-ways of Stoddard Road, Dale Road and Pirrone Road. This item adds those portions obtained by the Modesto City Schools District into the County's road system. As the political subdivision of the State of California, it is Stanislaus County's responsibility to maintain the County's road system.

Modesto City Schools District has provided the necessary documents for completing the transfer of title from the School District to the County.

### POLICY ISSUES:

This action is consistent with the Board's priorities of providing A Safe Community and A Well-Planned Infrastructure System. Accepting these roads into the maintained mileage will provide a safe and reliable transportation system to an important regional high school. Government Code 66477.1 states the legislative body of a county, or a county officer designated by the legislative body, may accept into the county road system, pursuant to Section 941 of the Street and Highway Code, any road from which an offer of dedication has been accepted or accepted subject to improvements.
