Approval to the Consent by Stanislaus County to Allow Right-of-Way Acquisition by the City of Modesto for the Pelandale Interchange Project

DISCUSSION:

The City of Modesto, in cooperation with the California Department of Transportation is proposing to reconstruct State Route 99/Pelandale Avenue Interchange in and near the City of Modesto, in Stanislaus County to alleviate traffic congestion and improve operations of State Route 99 and Pelandale Avenue.

Pursuant to Section 1810 of the Streets and Highways Code, Stanislaus County must consent to the acquisition of the right-of-way by the City of Modesto in the unincorporated area of the County (the affected parcels are noted as "Stanislaus County" on the attached Exhibit). By providing consent, the County is allowing the City of Modesto to acquire right-of-way by purchase or eminent domain within the County.

The Consent Form is attached along with the Right-of-Way Requirements Map.

POLICY ISSUES:

Consent by Stanislaus County to allow right-of-way acquisition by the City of Modesto will meet the Board's priorities of providing A Safe Community, A Healthy Community, A Well-Planned Infrastructure System, and the Effective Partnerships by cooperating with the City of Modesto for needed road improvements.



Consent by Stanislaus County to Allow Right-of-Way Acquisition By the City of Modesto

The City of Modesto, in cooperation with the California Department of Transportation ("Caltrans"), is proposing to reconstruct State Route 99/Pelandale Avenue Interchange in and near the City of Modesto, in Stanislaus County to alleviate traffic congestion and improve operations of State Route (SR) 99 and Pelandale Avenue. The project is to be designed consistent with the ultimate planned concept for SR 99.

An initial study with Mitigated Negative Declaration was prepared by the City's consultant and submitted to the State of California Department of Transportation (Caltrans) for approval. This document (SCH# 2009072012) was approved by Caltrans on September 28, 2009.

The proposed SR 99/Pelandale Avenue Interchange reconstruction would require acquisition of the land by the City of Modesto in the unincorporated area of the Stanislaus County necessary for the proposed interchange reconstruction.

Pursuant to Section 1810 of Streets and Highway Code, Stanislaus County consents to the acquisition of the right-of-way, by purchase or eminent domain, by the City of Modesto in the unincorporated area of the County necessary for the proposed interchange reconstruction project.

The County's consent is conditioned upon the City of Modesto advising at regular intervals the status and progress of such acquisition.
