FISCAL IMPACT:

Approval of the agreement with the State Department of Mental Health commits Behavioral Health and Recovery Services to the purchase of two State Hospital beds in Fiscal Year 2011-2012 at a cost of \$368,364. Sufficient funds were included in the Behavioral Health and Recovery Services budget for Fiscal Year 2011-2012 to fund the cost of State Hospital bed usage. There is no impact on the County General Fund.

Approval of the Renewal Agreement with the California Department of Mental Health for State Hospital Bed Usage for Fiscal Year 2011-2012 Page 2

DISCUSSION:

The State of California maintains three State Hospitals designed to treat individuals with serious mental illnesses who are in need of that level of care. Counties access psychiatric beds at the State Hospitals through agreements with the California Department of Mental Health. Annually, DMH requires each county to provide an estimate of the number of State Hospital beds needed throughout the fiscal year. Behavioral Health and Recovery Services submitted a request for two beds at Napa State Hospital for Fiscal Year 2011-2012. The subsequent agreement was recently received for the cost of the two beds from the DMH.

As Stanislaus County is charged for the contracted beds whether they are occupied or not, this agreement is closely monitored to assure the appropriateness of placements. If all the beds are not occupied by Stanislaus County residents, Behavioral Health and Recovery Services has the option to subcontract beds to other counties, or request an amendment to reduce the number of contracted beds, either of which results in savings.

As required in Contract Reporting Policy Number One, originally approved by the Board on January 24, 2006 and modified by the Board on March 22, 2011, the following table includes the cumulative value of prior contracts with this vendor for the period beginning July 1, 2009 through June 30, 2011.
