SUBJECT:

Approval to Process a Change Order with Roebbelen Contracting, Inc. for the Lump Sum Amount Not to Exceed \$41,536 to Establish Data Communication Service at the Stanislaus County Juvenile Commitment Facility Project Site Conditioned Upon Approval from the State of California Corrections Standards Authority

STAFF RECOMMENDATIONS:

- 1. Authorize the Project Manager to process a change order with Roebbelen Contracting, Inc. for the lump sum amount not to exceed \$41,536 to establish data communications service at the Stanislaus Juvenile Commitment Facility site conditioned upon approval from the State of California Corrections Standards Authority.
- 2. Authorize the Auditor-Controller to make the necessary budget transfers between the construction contingency and construction fixed assets accounts once the change order is approved by the State.

FISCAL IMPACT:

On December 10, 2010, the Board of Supervisors approved the project's initial financing plan. The original financing plan for the construction of a 60 bed facility was originally estimated not to exceed \$24,232,528. The financing plan includes State funding of \$18 million towards construction, funded through a lease-revenue bond financing plan. The primary sources of cash match the County has committed includes funding of \$1,725,000 from Public Facility Fees (PFF), funding of \$2,732,528 from the Criminal Justice Facility Fund, and a non-cash match from land valued at \$1,775,000 at the site where the new facility is being constructed, for a total match of \$6,232,528.

FISCAL IMPACT: (Continued)

On September 11, 2011, the Board of Supervisors approved a conditional award of a construction contract conditioned upon State approval to proceed with the construction of the Stanislaus County Juvenile Commitment Center Project to Roebbelen Contracting, Inc. for the lump sum amount not to exceed \$14,983,000, with a total project budget of \$22,713,828 outlined in the sources and uses chart below:

The change order contingency included within the approved project budget is 10% of the total construction contract, or \$1,498,300.

At this time, the Project Manager is returning to the Board of Supervisors for approval to process a change order with Roebbelen Contracting, Inc. for the lump sum amount not to exceed \$41,536 to establish data communications service at the Stanislaus Juvenile Commitment Facility site conditioned upon approval from the State of California Corrections Standards Authority. The Project Budget has funding for this proposed improvement.

This request is consistent with the County's Change Order Policy that requires Board of Supervisors' approval for any change order that exceeds \$25,000. The recommended Change Order is outlined in the Discussion section of this agenda item below.

DISCUSSION:

Project Background

Stanislaus County is partnering with the State of California to build a 60-bed Juvenile Commitment Facility. The project consists of the design and construction of a new, Approval to Process a Change Order with Roebbelen Contracting, Inc. for the Lump Sum Amount Not to Exceed \$41,536 to Establish Data Communication Service at the Stanislaus County Juvenile Commitment Facility Project Site Conditioned Upon Approval from the State of California Corrections Standards Authority Page 3

one-story juvenile commitment center adjacent to an existing juvenile detention center on county owned land. The project is being constructed on approximately 4.72 acres of the greater 33.4± acres of county owned land on which the county's existing juvenile facility is located. The juvenile commitment center will be dependent on the adjacent, existing facility for several core operational components, including, admission and release, central administration, the Medical Clinic, laundry, building maintenance, and the main warehouse.

The juvenile commitment center will be approximately 45,600 square feet and will provide 60 beds in three housing units. One housing unit will contain 30 beds, while the other two will each contain approximately 15 beds. This project also includes support services space for administration: central control: routine medical examinations; education, administration and classrooms; religious, recreational, and counseling programs; visitor processing and visitations; facility storage; and a service delivery and loading dock. The visitor processing and visitation space in this new facility may also be utilized for wards housed in the existing facility. Moreover, the central control in the new juvenile commitment center will be integrated with the electronics system at central control in the existing juvenile detention center so that the related functions can be transferred during sleeping hours to maximize staffing efficiencies.

In addition, this project will include the construction of a new vocational kitchen that will provide food service for both the new and the existing facility and support a culinary arts program. It will be located in the end of the new facility closest to the existing facility to facilitate food service to that building. A large multi-purpose room will be included as part of this project to provide indoor recreation and visitation. Two new outdoor recreation areas will be provided within secured fenced areas adjacent to the new housing units to provide direct access from the housing units. This project will also include, but is not limited to, electrical; plumbing; mechanical; computerized heating, ventilation, and air conditioning; security; and fire protection systems. Approximately 86 parking spaces will also be provided for both staff and visitor parking as part of this project.

Data Communication Service Project Design

The County contracted with Lionakis to design the project, and a contract to construct the project was awarded to Roebbelen Contracting, Inc. The contract as designed requires Roebbelen to connect the Telephone Termination Board (TTB) within the new Juvenile Commitment Center to an existing Minimum Point of Entry (MPOE) in the nearby Probation Building. The connection to the Commitment Facility will be by a 12 strand multi-fiber cable thru conduits being installed by the general contractor, essentially connecting the new Commitment Center to the existing Probation /Juvenile Hall Facility. The design had been closely coordinated with Probation Information Technology Division and the County's Strategic Business Technology Department and Capital Projects. As originally designed, the Commitment Facility would be deemed part of a "campus" and the County would be allowed only one MPOE on the campus.

Opportunities to Improve Data Communication Service

The Project Team concerned that the data and communications signal to the new facility relied upon an old facility and upon vulnerable overhead lines. After several meetings coordinated with the Probation IT and SBT departments in collaboration with AT & T engineers, staff determined the project could be improved and well protected by installing new underground conduit from the AT & T connection point to the new TTB.

The County's contract with State of California requires the County to construct a facility that will function independently. AT & T agreed to furnish service to a new MPOE within the Juvenile Commitment Facility. With this recommended change to the original design, the Commitment Facility can function independently.

Staff also determined that the 12 strand multi fiber connection between the new Telephone Termination Board in the Commitment Facility should be installed as designed to interconnect the Commitment Facility with the Probation Building and the Juvenile Hall. This connection will interconnect the Juvenile Hall and Probation Facilities directly with the Commitment Facility, and also, provide some emergency back-up in case of an interruption of service to either MPOEs.

The recommended redesign of the data communication services are anticipated to create several advantages over the original design which are outlined below:

- With the revised design, the Juvenile Commitment Facility will be an independent facility. The Commitment Facility will no longer rely upon other county facilities for utilities or services.
- The risk of an interruption to the data and communication services will be reduced. The arrangement as originally designed utilizes an overhead line susceptible to damage to connect to AT & T. The overhead line is also connected with another county facility and utilizes other county equipment for the data and communication signal. The revised design uses buried conduit with a direct connection to the new TTB in the Juvenile Commitment Facility.
- Interconnecting the MPOE within the Juvenile Commitment Facility with the MPOE within the Juvenile Probation building provides some emergency service in case service to either MPOE is interrupted.

Next Recommended Actions

The next critical step for the project recommends that the Board of Supervisors authorize the Project Manager to process a change order with Roebbelen Contracting, Inc. for the lump sum amount not to exceed \$41,536 to establish data communications service at the Stanislaus Juvenile Commitment Facility site conditioned upon approval from the State of California Corrections Standards Authority. The Project Budget has funding for this recommended improvement.

This change order is recommended to be funded out of existing appropriations in the construction contingency account. This request is consistent with the County Change Order Policy that requires Board of Supervisors approval for any change order that exceeds \$25,000.

<u>Schedule</u>

The Project Team has made significant progress towards construction of a Juvenile Commitment Facility. Time is of the essence, as this work must be completed before the site work on the project is completed in late Summer of 2012. To reduce costs, the conduit is recommended to be installed in the common trench with the natural gas line in late Summer of 2012 to ensure the project proceeds on schedule.

POLICY ISSUES:




Conduit for AT&T and Comcast:

As illustrated on the attached E1.1 drawing, provide two 4" conduits for AT&T and one 2" conduit for Comcast from Blue Gum north along Second Street, as indicated, and terminate to the contracted Splice Boxes (were relocated per RFI A-2023). Also provide additional pullboxes as shown.

The trench shall be on the east side of Second Street in the dirt. Provide trenching per utility requirements. Per prior discussions, share southern conduit installation with gas trench and widen to 24". Provide additional trenching that extends beyond gas to accommodate P.O.C. as shown. Patch and repair pavement per contract documents. At the remaining side road approaches (including north Second Street) crossed by the telephone/cable trench cut pavement, backfill, and top with compacted road base.
