Approval to Increase the District Attorney's Budgets for the Vertical Prosecution Block Grant and the Unserved/Underserved Victim Advocacy & Outreach Program

FISCAL IMPACT CONT:

Estimated revenue and appropriations for the Unserved/Underserved Victim Advocacy and Outreach Program totaling \$106,821 are reflected in Fiscal Year 2011-12 Final Adjusted Budget. This program was established in January of 2011 and is fully funded from Federal pass-through monies administered by CalEMA. Not all of the grant funds were expended in the first year (2010-2011) and the \$15,206 increase request represents an unspent amount that was expended in the first guarter of 2011-2012.

The increases requested for both of these budgets have no impact on the County's General Fund.

DISCUSSION:

The Vertical Prosecution Block Grant for Fiscal Year 2011-2012 is managed by the California Emergency Management Agency (CalEMA) and is supported by the Local Safety and Protection Account (LSPA). The LSPA comes from the Vehicle License Fee and is contingent upon revenues generated. Because of the uncertainty of the revenue source (VLF revenue not being strong enough to cover previous grant awards) county match in the amount of \$103,807 was the only budget amount established at the beginning of Fiscal Year 2011-2012. As VLF revenue has trickled in, late deposits to the LSPA fund have become available for distribution to local entities. On May 8, 2012, the Board of Supervisors granted approval for an increase of \$14,625 to the Vertical Prosecution budget in order to capture the revenue distributed to Stanislaus County. The \$2,032 increase to appropriations and estimated revenue included in this agenda item is representative of an additional allocation as a result of additional deposits of VLF monies. If approved, the total budget for Vertical Prosecution Block Grant budget will be \$120,464.

Federal funding for the Unserved/Underserved Victim Advocacy and Outreach Program was granted to the District Attorney's Office for a five-year period beginning in Fiscal Year 2010-2011. The grant award is based on the Federal Fiscal Year of October 1 through September 30 and an application for continuation funding is required for years two through five. At the end of the County's Fiscal Year 2010-2011 (the first three quarters of the Federal Fiscal Year award), a portion of the available funds was unspent because not all of the expenditures for contracted outreach and educational activities were invoiced to the District Attorney's Office by the contractor. These cost were invoiced in the first quarter of the 2011-2012 fiscal year and were still covered under the first year of the Federal Fiscal award. In order to properly account for and reimburse these expenditures, an increase of \$15,206 in appropriations and estimated revenue is necessary in the current fiscal year of 2011-2012. If approved, the total budget for the Unserved/Underserved Victim Advocacy and Outreach Program will be \$122,027 and will adequately account for all eligible costs.

Existing Staff in the District Attorney's Office continues to administer the Vertical Prosecution Block Grant and to sustain grant reporting requirements for the Unserved/Underserved Victim Advocacy and Outreach Program.
