### **STAFF RECOMMENDATIONS (Continued):**

 Authorize the HSA Managing Director, her designee or successor, to negotiate and sign individual amendments to the agreements, not to exceed \$75,000 per agreement.

#### **DISCUSSION:**

The attached list of Independent Contractors includes direct medical provider contractors which fulfill the mission of the HSA in providing medical care to County Indigents and other County patients.

Consistent with the policy adopted by the Board of Supervisors on January 24, 2006, and amended on March 22, 2011, the attached list includes those contractors for whom Board approval is required as the cumulative amount estimated to be paid to these contractors by the HSA from the period July 1, 2010 through June 30, 2013 will be more than \$100,000, as well as those that are required to be reported to the Board of Supervisors, as the cumulative amount for that period is in excess of \$50,000.

The total amount of contracts over \$100,000 cumulatively, to be approved by the Board of Supervisors through this agenda item is \$297,686 for Fiscal Year 2011-2012 and \$260,000 for Fiscal Year 2012-2013. These contract amounts were already approved by the Board of Supervisors but the actual vendor or vendor name has changed since that approval.

#### **POLICY ISSUES:**

Approval of these recommendations supports the Board's priorities of A Healthy Community, Effective Partnerships, and Efficient Delivery of Public Services through effectively securing available, needed resources in a planned, organized and compliant manner.
