#### **DISCUSSION:**

This is a three-part application requesting to make the following modifications to a 4.31 acre parcel located in the Del Rio Community Plan area: 1) Amend the General Plan designation from LDR (Low Density Residential) to P-D (Planned Development) and the Del Rio Community Plan (part of the General Plan) residential unit density allowance from 2 to 4.5 dwelling units per acre; 2) Amend the Zoning designation from R-A (Rural Residential) to P-D (Planned Development); and 3) Subdivide into a gated development of 18 condominiums and a common area parcel which will include landscaping, a swimming pool, access easements, an on-site package wastewater treatment plant, and drainage. The project will be served by public water from the City of Modesto (Del Este). The condominium parcels will be approximately 5,100 to 7,200 square feet in size

On November 4, 2010, the Planning Commission heard General Plan Amendment Application No. 2010-02, Rezone Application No. 2010-02, and Vesting Tentative Subdivision Map 2010-01 - Del Rio Villas. This current application is exactly the same project that was heard on November 4, 2010. The Planning Commission voted 3-2 to recommend denial of the 2010 application to the Board of Supervisors; however the applicant withdrew the application before it could be heard by the Board of Supervisors.

The current application was heard by the Planning Commission at a public hearing on July 5, 2012, and on a 6-1 vote recommended the Board of Supervisors deny the request.

At this time, this item simply sets the date and time for a hearing on the matter before the Board of Supervisors to consider the proposed request.

#### **POLICY ISSUES:**

The Board should determine if setting a hearing for this proposed general plan amendment and rezone furthers the goals of Efficient Delivery of Public Services.
