FISCAL IMPACT: It is not known, at this time, what the proceeds of the auction will be. Based on previous sales of similar vehicles and equipment, proceeds are estimated to total \$32,000. Approval to Declare Forty County Vehicles and Miscellaneous Equipment as Surplus and Authorize Their Sale at Auction

DISCUSSION:

It is recommended that the Board approve the request to declare as surplus, the attached list (Attachment A) of County vehicles and miscellaneous equipment, and authorize their sale. The vehicles and equipment have outlived their useful life and no longer have value as County assets.

County Ordinance 2.24.065 allows for the sale of surplus property with a residual value greater than one thousand dollars upon approval by the Board of Supervisors.

2.24.065 Sale of personal property.

The purchasing agent is authorized to sell, trade, trade in, lease, exchange, or otherwise dispose of any personal property belonging to the county which is deemed to be surplus and not required for public use by the county and which has a value of less than one thousand dollars per individual item without prior approval by the board of supervisors. Notwithstanding any other provision of this code, such disposition of surplus property may be made without securing bids or advertising. For disposition of personal property exceeding one thousand dollars per individual item, prior approval from the board of supervisors must be obtained. All proceeds from such sales shall be paid into the county treasury for the use of the county. (Ord. CS 475 §3, 1992).

The attached list of vehicles and equipment are recommended for auction. The vehicles, many of which have been used in our Emergency Vehicle Operations Course (EVOC), are in very poor condition and the cost to repair exceeds the value of the vehicle. Additionally, many of these vehicles, due to age and condition, no longer meet emissions standards. All vehicles are screened, prior to inclusion on the list, for other uses within the County. A vehicle which has any useful life, or can be economically salvaged for parts, is not eligible for auction. Continued use by any County department without extensive repairs could lead to additional public safety liability on the part of the County.

The vehicles and equipment will be turned over to an auction company, which will sell them and return the net proceeds to the General Services Agency (GSA) – Fleet Services Division. GSA – Fleet Services staff time and expenses incurred in processing the vehicles and equipment will be deducted from the proceeds and deposited to 5021-18510-46000, prior to distribution of proceeds to departments.

POLICY ISSUES:

The sale of poor condition vehicles and equipment is consistent with Board of Supervisors' priority of Efficient Delivery of Public Services. Funds generated by the sale of such equipment are returned to departmental budgets for use by departments.
