### **STAFF RECOMMENDATIONS (Continued):**

- 4. Retain a 30 foot emergency access easement for the benefit of the Stanislaus Consolidated Fire Protection District (SCFPD) centered on the existing centerline of Marquette Lane as shown in Exhibit "C".
- 5. Retain the easterly 15 feet as a Public Utility and Drainage easement for the benefit of Stanislaus County.
- 6. Adopt the attached resolution vacating that portion of Marquette Lane lying on the west side of Gold Run Drive as described in the attached Exhibit "A" and "B".
- 7. The Clerk of the Board shall record a certified copy of the resolution in accordance with Street and Highway code section 8336.

### DISCUSSION:

The adjacent homeowners, Tim and Dorothy McKinsey and Gary and Susan Hunter, have requested the abandonment. This portion of Marquette Lane is located at the intersection of Gold Run Drive, lying south of Highway 108 and east of the City of Riverbank. The lane was originally offered for dedication as part of a Parcel Map application in 1991 and recorded in Volume 46 of Parcel Maps on December 29, 1993. Since that time the lane has not been improved or used for road purposes. Public Works has determined that this portion of Marquette Lane is excess right-of-way and is not needed for future road purposes. The abandoned area will revert back to the adjacent land owners who currently own the underlying fee title of this property.

Local utility companies have been notified. They do not have facilities within the abandonment area and do not require easements. An Emergency Vehicle Access Easement will be retained for the benefit of the Stanislaus Consolidated Fire Protection District and a Drainage and Public Utility Easement will be retained for Stanislaus County, as described in Exhibits "A", "B", and "C".

### POLICY ISSUES:

The recommended actions are consistent with the Board's priority of A Well Planned Infrastructure System by removing any excess right-of-way that is not needed for road way purposes, therefore removing any liability. Street and Highways Code 8334(a) states that the legislative body of a local agency may summarily vacate excess right-of-way of a street or highway not required for street or highway purposes.

### STAFFING IMPACT:

There is no staffing impact associated with this item.








