#### **CONFLICT OF INTEREST CODE**

#### WESTERN HILLS WATER DISTRICT

The Political Reform Act, Government Code Section 81000, et seq., requires each state and local government agency to adopt and promulgate a conflict of interest code. The Fair Political Practices Commission has adopted a regulation, 2 Cal. Code Regs., Section 18730, which contains the terms of a standard conflict of interest code ("Standard Code"). The Standard Code can be incorporated by reference and may be amended by the Fair Political Practices Commission after public notice and hearings to conform to amendments in the Political Reform Act. Therefore, the terms of 2 Cal. Code Regs., Section 18730, and any amendments to it duly adopted by the Fair Political Practice Commission are hereby incorporated by reference and along with the attached Appendix consisting of this Attachment "A" and Attachments "B" through "D", in which members and employees are designated and disclosure categories are set forth, and the place of filing is specified, shall constitute the Conflict of Interest Code of the Western Hills Water District ("District").

Persons holding designated positions and designated employees shall file statements of economic interests with the Secretary of the District. Upon receipt of the statements of the various designated persons, the Secretary of the District shall retain the original of these statements at the designated place of filing, as indicated on Attachment "D".
