ORDINANCE NO. C.S. 1124

AN ORDINANCE TO AMEND SECTIONS OF THE STANISLAUS COUNTY CODE

THE BOARD OF SUPERVISORS OF THE COUNTY OF STANISLAUS, STATE OF CALIFORNIA, DO ORDAIN AS FOLLOWS:

Section 1. Sections 2.40.040, 2.40.050, 2.40.060, and 2.40.090 of the Stanislaus County Code are hereby amended as follows:

2.40.040 Officer Election.

"The park commission shall organize by electing one of its members chairperson and one member vice-chairperson. It shall also elect a secretary, who need not be a member. The officers of the park commission shall be elected on the last regular meeting of each calendar year for a term of one year."

2.40.050 Meetings.

"The park commission shall establish a time and place for regular meetings which shall be held at least once every two months. Special meetings maybe held upon the call of the chairperson."

2.40.060 Quorum.

"The majority of appointed park commissioners shall constitute a quorum for the transaction of business by the park commission, but a lesser number may convene from time to time. In the event that two member vacancies on the park commission exist simultaneously, then a quorum shall consist of a majority of the currently serving members."

2.40.090 Vacancy because of absence.

"After a member of the park commission fails to attend three consecutive meetings, unless excused by the majority vote of the commission, his/her membership thereon shall be automatically terminated and a successor shall be appointed by the board of supervisors to serve for the unexpired portion of the term." **Section 2.** This ordinance shall take effect 30 days from and after the date of its passage and before the expiration of 15 days after its passage it shall be published once, with the names of the members voting for and against the same, in the Modesto Bee, a newspaper published in the County of Stanislaus, State of California.

Upon motion of Supervisor <u>Withrow</u> seconded by Supervisor <u>Monteith</u>, the foregoing Ordinance was passed and adopted at a regular meeting of the Board of Supervisors of the County of Stanislaus, State of California, this <u>4th</u> day of <u>December</u>, 2012, by the following-called vote:
