Re: Appointment of Trustees to RD 2092 Board

Dear Ms. Tallman:

I am writing on behalf of River Partners, a landowner within Reclamation District No. 2092 in Stanislaus County. Landowners in the District have recently taken steps to re-activate the district in order to serve a leadership role in the region's flood control efforts, a collaborative effort between the District and the County, as well as enter into a funding agreement between the State and the District as part of the Central Valley Flood Protection Plan regional planning process. Each of these efforts would require the Board of Trustees of the District to authorize the District to move forward, but because of the District's prior inactive status there are no current members of the Board of Trustees.

The County has authority to appoint Trustees to the District's Board in the event of a vacancy pursuant to California Water Code Section 50604 and Government Code Section 1780. Under these sections, a County ordinarily exercises this power after either: (a) an election has been called, but the number of vacant seats is greater than the number of nominees for the vacant position; or (b) a vacancy occurs, and the current Board of Trustees fails to take action to appoint a replacement or call an election within 60 days. Here, the entire Board is vacant, and therefore incapable of either calling a replacement or appointing a new trustee. In these unique circumstances, the landowners of the District request that the County appoint John Carlon, Bob Ott and Mike Nutcher to the Board of Trustees at its next Board of Supervisors' meeting, to serve pursuant to Government Code Section 1780 (f) until a General District Election can be called in 2013.

The landowners also request that the County Treasurer consent to the appointment of Jessica Bourne as the District treasurer under Water Code Section 50660.
