Please accept this is as my resignation effective immediately from the Airport Advisory Committee, there are a plethora of reasons for my decision. I feel that the committee is spinning its wheels and is never going to be the advocate for General Aviation growth at the airport. A classic example is approving a tenant rate increase in a trending downward economic city.

In the past several meetings we have engaged an open forum of topics that in my mind are a waste of energy. The committee is not pressing to find solutions to the real issues of diminishing GA aircraft and interest in GA. I feel the city of Modesto is walking a fine line in breaching many GA rights that could lead to AOPA and EAA involvement and support.
