# FISCAL IMPACT (Continued):

On September 20, 2011, the Board of Supervisors adjusted the project budget at the time of the award of the construction project as a result of bids coming in below the estimate; the total Project Cost was reduced from the Financing Plan estimate of \$24,232,528 to \$22,713,828. This budget adjustment resulted in a net savings of \$1,518,700 for the State of California. The primary sources of cash match the County has committed to the Juvenile Commitment Center project includes funding of \$1,725,000 of Public Facility Fees (PFF), funding of \$2,732,528 from the Criminal Justice Facilities Fund, and a non-cash match from land valued at \$1,775,000 at the site where the new facility is being constructed.

At this time, staff is requesting the Board of Supervisors approve the final contract with Roebbelen Contracting, Inc. of El Dorado Hills, California for the final contract cost of Approval of the Final Acceptance of the Construction of the Juvenile Commitment Facility with Roebbelen Contracting, Inc. of El Dorado Hills, California; and Related Actions

\$14,983,000. During the course of construction, the Project Manager processed change order requests totaling \$541,581, consistent with the County's Change Order Policy, which increased the final contract cost from \$14,983,000 to \$15,524,581.

While the final close-out of all activities is nearing completion the Project Manager estimates the total project cost will not exceed \$21,757,109, with the project being completed on time and *significantly* under the approved budget of \$22,713,828. The savings are derived from the original design and bid day savings of \$1,518700 and additional savings in the amount of \$956,719 in Youthful Offender Rehabilitative Construction (SB-81) funding back to the State of California from savings in the construction contingency. At the time of Final Completion of the Juvenile Commitment Facility the total State savings of SB-81 funding is \$2,475,419. The Board of Supervisors approved County cash match included in the Project Budget was not increased at the time of Final Completion.

As the awarding authority, the Board of Supervisors is also requested to authorize the Project Manager to sign the completion documents, record the Notice of Completion effective March 28, 2013, release retention less withholdings, and process all remaining closeout activities for the above contracts and the project. As part of the closeout activities, the County will be withholding \$65,550 from Roebbelen Contracting, Inc. for incomplete work on the Project. Consistent with applicable law, the Project Manager will be withholding this amount to allow certain minor punch list items to be completed after the filing of the Notice of Completion. The withholding payment of up to \$65,550 will be made to Roebbelen upon completion of the mutually agreed upon withholding punch list items (final completion items).

# **DISCUSSION:**

Stanislaus County partnered with the State of California to build a 60-bed Juvenile Commitment Center at 2215(A) Blue Gum Avenue, Modesto, CA. On March 31, 2009, the Board of Supervisors acknowledged an award up to \$18 million from the State of California Corrections Standards Authority for the construction of a 60-Bed Juvenile Youth Treatment Facility and directed staff to negotiate a contract with the State to build the Juvenile Youth Treatment Facility (YTF) with funds under the Department of Corrections 2007 Youthful Offender Rehabilitative Facility Construction Funding Program (SB-81). The State of California is required to sell bonds to provide construction financing for the program. The bonds for this Project were sold by the State in March, 2013.

On January 12, 2010, the Board of Supervisors authorized the Project Manager to negotiate and sign contracts and work authorizations necessary to manage schematic design including construction management, professional services and other project related costs. On January 12, 2010, the Board of Supervisors approved retaining the Lionakis, Inc. firm for professional design services for the development of plans and

specifications for the construction of the new Juvenile Commitment Facility, not to exceed \$1.9 million. On August 3, 2010, the Board approved the schematic design as prepared by Lionakis, Inc. The project consisted of a stand-alone 46,998 square foot Juvenile Commitment Facility with the required outdoor recreation yard, a new parking lot to accommodate the facility staff and visitors, and a small amount of landscaping. The Juvenile Commitment Facility included one 30-bed housing unit and two 15-bed housing units with a mix of single and double sleeping rooms, and 4-bed dormitory-type rooms. The facility includes code required medical screening, interview rooms, classrooms, multi-purpose space, a culinary program classroom, food service and various support spaces for staff services.

On September 20, 2011, the Board of Supervisors approved the award of the construction contract for the Juvenile Commitment Center to Roebbelen Contracting, Inc. in the lump sum of \$14,983,000. The Project met a significant milestone of Substantial Completion on February 11, 2013. Final Completion of the Construction Contract with Roebbelen Contracting, Inc. occurred on March 28, 2013. Occupancy of the building by youth offenders is scheduled to occur prior to June 28, 2013.

A tremendous multi-year effort by the Board of Supervisors, County staff and State partners, along with the Lionakis Design Team and the Roebbelen Construction Team, resulted in the successful completion of the first statewide Local Youthful Offender Rehabilitative Construction Funding (SB 81) Commitment Facility. The project was completed on time, and within the previously approved project budget. A public dedication event will be held on June 7, 2013 to celebrate the successful completion of this milestone partnership project between the County and State of California.

# Schedule

Final Completion of the Construction Contract with Roebbelen Contracting, Inc. occurred on March 28, 2013. A public dedication event is scheduled to be held on June 7, 2013. Occupancy of the building will occur prior to June 28, 2013 consistent with the State guidelines and Board approved Probation Transition Plan. Consistent with the Board of Supervisors approved Transition Plan, an access driveway has recently been completed meeting the final obligation the County has to the State.

## **POLICY ISSUES:**

Approval of this action promotes the Board's priorities of A Safe Community and Efficient Delivery of Public Services by making the most cost effective and efficient use of County resources to complete a project that enhances a large scale capital project for the County.

THIS AGREEMENT AND RELEASE OF ANY AND ALL CLAIMS ("Agreement and Release"), made and entered into this 16th day of April, 2013, by and between the County of Stanislaus ("County"), and Roebbelen Contracting, Inc. ("Contractor"), whose place of business is at 1241 Hawks Flight Court, El Dorado Hills, California 95762.

#### **RECITALS**

- A. County and Contractor entered into Contract (the "Contract") for construction of the County of Stanislaus **Juvenile Commitment Center** located at **2215A Blue Gum Avenue**, **Modesto**, **California 95358**.
- B. The Work under the Contract has been completed.

# **AGREEMENT**

NOW THEREFORE, it is mutually agreed between County and Contractor as follows:

It is the intention of the parties in executing this Agreement and Release that this Agreement and Release shall be effective as a full, final and general release of all claims, demands, actions, causes of action, obligations, costs, expenses, damages, losses and liabilities of Contractor against County, and all if its agents, employees, consultants, inspectors, representatives, assignees and transferees, except for the Disputed Claims set forth in Paragraph 4 of this Document 00 65 00. Nothing in this Agreement and Release shall limit or modify Contractor's continuing obligations described in Paragraph 6 of this Document 00 65 00.
- 4. The following claims submitted under Document 00 70 00 (General Conditions), Article 12, are disputed (hereinafter, the "Disputed Claims") and are specifically excluded from the operation of this Agreement and Release.
