Approval to Adopt a Resolution Certifying the Stanislaus County Maintained Road System Mileage

DISCUSSION:

Section 2121 of the California Streets and Highways (S&H) Code confers upon the Board of Supervisors the authority, duties, and limitations that have to do with the establishment and maintenance of the county road system. All agencies are required to submit an annual Maintained Mileage Report to the California Department of Transportation (Caltrans). The previous maintained mileage report was adopted by the Board of Supervisors on April 24, 2012.

The main objective of this activity is to supply the necessary information for distribution of HUTA funds in accordance with Section 2104 of the S&H Code.

The total maintained mileage as of December 31, 2012 is 1,512.94 miles. This is a net decrease of 8.24 miles from the previously reported mileage of 1,521.18 miles as of December 31, 2011. This net decrease is due to various annexations and road additions as seen in the attached table summary (Exhibit A).

POLICY ISSUES:

Approval of the maintained mileage is an integral part of Public Works' funding for road maintenance and repair through HUTA fund allocation and supports the Board's priority of A Well Planned Infrastructure System.
