SUBJECT:

Approval to Adopt Plans and Specifications for the Salida Sidewalk Repair Project, and Set Bid Opening Date

STAFF RECOMMENDATIONS:

1. Adopt the Plans and Specifications for the Salida Sidewalk Repair Project.
2. Direct the Department of Public Works to set the bid opening date and time.
3. Direct the Public Works Department to publish and mail the notice inviting bids to trade journals as required by law.

FISCAL IMPACT:

The total estimated construction cost for all phases of this project is \$320,000. The funding for this project will be provided from County Service Area (CSA) 10 capital reserve funds. Reserve funds of approximately \$300,000 have been set aside primarily for pump replacement and other capital needs. However, due to the condition of the sidewalks, Public Works staff's recommendation is to use a portion of the reserve for the proposed project. There are insufficient reserve funds to construct the project in a single operation; therefore, the project will be constructed in multiple phases. Phase 1 of the project will use \$165,000 of the available reserve funds. As of April 30, 2013, the reserve fund (continued on Page 2)



balance was \$300,000. The remaining project phases will be constructed once sufficient funds have accumulated or other funding is identified.

DISCUSSION:

The Salida Sidewalk Repair project lies within the boundaries of CSA 10, lying north of Kiernan Road and east of State Highway 99. CSA 10 was established in October 1990, to provide extended service and maintenance for parks, streetscapes, and storm drain facilities.

The purpose of the Salida Sidewalk Repair Project is to improve public pedestrian safety. The existing streetscape consists of meandering sidewalks, landscaping and street trees that were placed along the roadside of collector streets within the Salida Planned Development in the 1990's. Currently, large cracks and vertical displacement of the concrete sidewalks present a potential tripping hazard for pedestrians. The damage to the sidewalks appears to be directly related to the root systems of the street trees. The sidewalk issues addressed by this project primarily exist along Pirrone Road, Finney Road, and Sisk Road. As part of this sidewalk repair project, existing street trees shall be removed and replaced with trees that include root control systems.

The Stanislaus County Public Works and Parks and Recreation Departments initially presented this project to the public at the Salida Municipal Advisory Council (MAC) meeting on March 26, 2013. A follow-up discussion was held at the Salida MAC meeting on April 23, 2013, to consider including tree replacement as part of this project. A final meeting with the Salida MAC was held on May 28, 2013 to finalize the tree type to be used.

Phase 1 of this project includes the repair of a majority of the damaged sidewalks along Pirrone Road that is estimated to cost \$165,000. Future phases of the project are intended to repair the remaining sidewalks along Pirrone Road, Finney Road, and Sisk Road, as additional CSA 10 funding becomes available. The total estimated cost for future phases is \$155,000.
