# DISCUSSION:

On January 24, 2006, the Board of Supervisors adopted 8 policies for the approval and reporting of contracts and agreements (each a Contract Reporting Policy). Contract Reporting Policy Number Three requires the Purchasing Agent to prepare a report to the Board of Supervisors of all contractual services (except Personal Service Contracts) provided by vendors/contractors not previously reported for more than one County Department during the fiscal year where the total exceeds \$50,000. The last report was presented to the Board on July 17, 2012, covering the period from July 1, 2010 through June 30, 2011.

The attached reports contain vendors/contractors not previously reported to the Board of Supervisors, where the payments cross more than one department and were greater than \$50,000 in the fiscal year beginning July 1, 2011 and ending June 30, 2012 and fiscal year beginning July 1, 2012 and ending June 30, 2013. Applicable departments have reviewed and approved these reports.

The attached reports fulfill the Purchasing Agent's requirement to report annually all contractual services, except Personal Service Contracts, provided by vendors/contractors for more than one County Department during the fiscal year where the total exceeds \$50,000, set by Board Resolution 2006-58.
