

Pursuant to Government Code section 1780, the Board of Directors of the district has decided to fill the vacancy by appointment. The person appointed will hold office until the next District general election.

The District Board invites interested persons to apply for the position of Director. In order to serve as Director, a candidate must be a landowner of the District, or a legal representative of a landowner. The person appointed will be required to attend regular District Board meetings.

The District Board will make an appointment on January 16, 2014. Persons interested in being considered for appointment to the District Board should apply by application or letter, stating their qualifications, background and reasons for seeking appointment.
