DISCUSSION:

It is recommended that the Board approve the request to declare as surplus, the attached list (Attachment A) of County vehicles and miscellaneous equipment, and authorize their sale. The vehicles and equipment have outlived their useful life and no longer have value as County assets. Each of the vehicles has been reviewed and verified by the General Services Agency (GSA) Fleet Services Manager for inclusion in this list. Of the 67 vehicles being salvaged, 27 vehicles were replaced as part of the normal budget process, 23 vehicles were replaced with vehicles rotated from within the department or reassigned from another department, and 17 vehicles are not being replaced.

County Ordinance 2.24.065 allows for the sale of surplus property with a residual value greater than one thousand dollars upon approval by the Board of Supervisors.

2.24.065 Sale of personal property.

The purchasing agent is authorized to sell, trade, trade in, lease, exchange, or otherwise dispose of any personal property belonging to the county which is deemed to be surplus and not required for public use by the county and which has a value of less than one thousand dollars per individual item without prior approval by the board of supervisors. Notwithstanding any other provision of this code, such disposition of surplus property may be made without securing bids or advertising. For disposition of personal property exceeding one thousand dollars per individual item, prior approval from the board of supervisors must be obtained. All proceeds from such sales shall be paid into the county treasury for the use of the county. (Ord. CS 475 §3, 1992).

The attached list represents vehicles and equipment to be salvaged and sent to auction due to various issues related to age, condition, and emissions requirements. The GSA Fleet Manger has screened all vehicles, prior to inclusion on the list, for other uses within the County. Any vehicle determined to have a useful life, without extensive repairs, is reassigned to another department or Fleet Motor Pool. Continued use by any County department of the vehicles proposed for auction, without extensive repairs, could lead to additional public safety liability on the part of the County.

Upon Board approval, the vehicles and equipment will be turned over to an auction company, which will sell them and return the net proceeds to the GSA – Fleet Services Division. GSA – Fleet Services staff time and expenses incurred in processing the vehicles and equipment will be deducted from the proceeds and deposited to 5021-18510-46000, prior to distribution of proceeds to departments.

POLICY ISSUES:

The sale of poor condition vehicles and equipment is consistent with Board of Supervisors' priority of Efficient Delivery of Public Services. Funds generated by the sale of such equipment are returned to departmental budgets for use by departments.
