Approval to Summarily Vacate That Portion of Fairbanks Avenue Located Between Grand Street and Modesto & Empire Traction (M&ET) Railroad, South of the City of Modesto

DISCUSSION:

An abandonment application was filed by Stantec Consulting, Inc., on behalf of E. & J. Gallo Winery, the landowners. The abandonment is being sought to permit the construction of a new office building. Abandonment of the City of Modesto's right-of-way, adjacent to the County's right-of-way, is also being pursued through the City.

The Department of Public Works has determined that all property within the abandonment area is owned by E. & J. Gallo Winery and is no longer needed for public right-of-way (ROW).

The abandonment area was originally dedicated as Fairbanks Avenue with Vol. 477 of deeds, Page 86, recorded on September 13, 1932. On December 21, 1965 all of Fairbanks Avenue, south of Gilmore Avenue, was abandoned with document Book 2076, Page 314. The adjacent Gilmore Avenue was abandoned on March 28, 1985. This left a portion of Fairbanks Avenue, north of Gilmore Avenue, remaining. The requested action is to abandon the remaining ROW of Fairbanks Avenue.

Street and Highways Code 8334(a) states that the legislative body of a local agency may summarily vacate an excess ROW of a street or highway not required for street or highway purposes.

The utility easements within the project boundaries are to remain for the benefit of existing utility facilities.

POLICY ISSUES:

The recommended actions are consistent with the Board's priority of A Well Planned Infrastructure System by removing any excess ROW that is not needed for roadway purposes, therefore removing any liability.

STAFFING IMPACT:

There is no staffing impact associated with this item.

LEGAL DESCRIPTION FOR RIGHT-OF-WAY VACATION

All that certain portion of land dedicated as public highway by that certain document filed in Book 477 of Official Records, at Page 86, Stanislaus County Records, lying in Section 33, Township 3 South, Range 9 East, Mount Diablo Base and Meridian, in the unincorporated area of the County of Stanislaus, State of California, being more particularly described as follows:


COMMENCING at the intersection of the south line of Grand Street with the East line of South Morton Boulevard as shown on the map of Block 220 of the City of Modesto, filed in Book 15 of Maps, at Page 220, Stanislaus County Records, thence, along the south line of Grand Street, South 89°22'50" East 61.83 feet; thence, continuing along the south line of said Grand Street, South 86°20'32" East 134.48 feet; thence, continuing along the south line of said Grand Street, also being along the existing City Limits Line as described in the La-Loma/Yosemite Annexation file in 4 December, 1953, South 86°03'32" East 214.64 feet, to the TRUE POINT OF BEGINNING of this description; thence, continuing along the existing City Limits Line, South 86°03'32" East 133.99 feet, to a point on said City Limits Line of that portion of Yosemite Boulevard vacated by that certain document entitled "Vacation of Superseded State Highway", recorded on October 7, 1992, as Document No. 096661, Stanislaus County Records, said point being the beginning of a non-tangent curve, concave to the northwest, from which a radial line bears North 49°11'08" West, having a radius of 50.00 feet and a central angle of 56°32'26"; thence, along the arc of said curve, also being along the limits of said vacated portion of Yosemite Boulevard, 49.34 feet; thence, continuing along the limits of said vacated portion of Yosemite Boulevard, South 77°59'59" East 49.72 feet, to the beginning of a non-tangent curve, concave to the east, from which a radial line bears South 60°18'32" East, having a radius of 11.70 feet and a central angle of 137°01'30"; thence, along the arc of said curve, 27.98 feet, to a point on the north line of Gilmore Avenue as vacated by that certain document recorded on March 4, 1985, as Document No. 040185, and recorded again on March 28, 1985, as Document No. 044516, Stanislaus County Records; thence, along the north line of said vacated Gilmore Avenue, South 72°39'58" West 117.44 feet, to a point on the west line of Fairbanks Avenue as vacated by that certain document recorded on December 23, 1966, in Volume 2076 of Official Records, at Page 314, Stanislaus County Records; thence, along the west line of said vacated Fairbanks Avenue, North 29°40'46" East 8.10 feet, to the beginning of a curve, concave to the southwest, having a radius of 54.51 feet and a central angle of 115°44'18"; thence, along the arc of said curve, 110.11 feet, to the TRUE POINT OF BEGINNING.


