AN ORDINANCE AMENDING STANISLAUS COUNTY CODE, SECTION 11.08.020 RELATING TO RED CURB MARKING – STREETS DESIGNATED ON KIERNAN AVENUE, IN THE SALIDA AREA

THE BOARD OF SUPERVISORS OF THE COUNTY OF STANISLAUS ORDAINS AS FOLLOWS:

- Section 1 Amend Stanislaus County Code, Section 11.08.020: Red Curb Marking Streets Designated Paragraph 454 to read as follows:
- "454 Kiernan Avenue. On the north side of Kiernan Avenue from its intersection thereof with Toomes Road, west to a point three hundred ten feet west of the intersection; and on the north side of Kiernan Avenue from a point seven hundred forty feet west of its intersection with Toomes Road, west one hundred feet to a point eight hundred forty feet west of the intersection; and on the north side of Kiernan Avenue from a point nine hundred twenty feet west of its intersection with Toomes Road, west sixty feet to a point nine hundred eighty feet west of the intersection; and on the north side of Kiernan Avenue from a point one thousand, two hundred forty-five feet west of its intersection with Toomes Road, west sixty feet to a point one thousand, three hundred five feet west of the intersection; and on the north side of Kiernan Avenue from its intersection thereof with Toomes Road east to a point nine hundred feet from the intersection; and on the south side of Kiernan Avenue from its intersection thereof with Toomes Road east to a point one hundred feet from the intersection; and on the south side of Kiernan Avenue from its intersection thereof with Toomes Road west to a point three hundred ten feet from the intersection;"
- Section 2. This ordinance shall take effect 30 days from and after the date of its passage, and before the expiration of 15 days after its passage, it shall be published once with the names of the members voting for and against the same in the Modesto Bee, a newspaper in the County of Stanislaus, State of California.
