On the north and south sides of Bangs Avenue from its intersection thereof with McHenry Avenue, west to a point four hundred and sixty feet of said intersection; and on the north and south sides of Bangs Avenue from its intersection thereof with McHenry Avenue, east to a point one-hundred and forty feet of said intersection."

This ordinance shall take effect 30 days from and after the date of its passage, and before the expiration of 15 days after its passage, it shall be published once with the names of the members voting for and against the same in the Modesto Bee, a newspaper in the County of Stanislaus, State of California.





AN BRBINANCE AMENDING STANISLAUS COUNTY CODE, SECTION 11.03.20 RELATING TO RED CURB MARKING - STREETS DESIGNATED ON BANGS AVENUE, IN THE MODESTG AREA. The Board of Supervisors of the County of Stanislaus County codes Section 1. Amend the Stanislaus County Code. Section 10.0202: Red Curn Marking - Streets Designated to add, Paragraph 546 to read as follows: "500. Bengs Avenue.
