#### **DISCUSSION:**

Stanislaus County employs Family Services Specialists at the Alliance Worknet, Behavioral Health and Recovery Services Agency, Community Services Agency (CSA), and the Health Services Agency.

The Family Services Specialists play a critical role in administering programs and services in Stanislaus County by providing a safety net for needy individuals and families who lack basic necessities in life, such as food, shelter, clothing, and health care.

The CSA Family Services Specialist has many roles. The position's main responsibilities are to serve the public by determining their eligibility for public assistance in the Medi-Cal, CalFresh, CalWORKs, Welfare-to-Work, Refugee Assistance, Child Care, Cal-Learn, and General Assistance programs and to coordinate resources for providing for the needs of children in placement in the Foster Care, Extended Foster Care, Adoption Assistance and Kin-GAP programs. They do this by interviewing customers, collecting relevant information, interpreting complex rules and regulations, ensuring accurate and timely benefit issuance, and providing customers with resources to help with immediate need situations. For many of the customers they see on a daily basis, the customers are at the most stressful and challenging time in their lives. The Family Services Specialist must help the customer navigate a very complex process to receive benefits. They must do this under demanding circumstances while providing excellent customer service to the public.

In Fiscal Year 2012-2013, over 196,461 or 37.6% of the County's residents relied on the Agency for benefits and services. The Family Services Specialists in the StanWORKs Division were responsible for the accurate issuance of over \$259 million in CalWORKs Cash Aid, Refugee Assistance, Cash Assistance Program for Immigrants, General Assistance, and CalFresh benefits.

Family Services Specialists provide employment services to families receiving CalWORKs through the Welfare-to-Work Program. Employment services are designed to assist families and individuals reduce barriers to and enhance opportunities for long-term employment. In Fiscal Year 2012-2013, 4,083 participants enrolled in the program and 1,391 received job placements.

Access to child care services is an essential element in assisting customers to obtain training, secure employment, and eventually become self-reliant. Family Services Specialists link parents with child care providers and issued payments on behalf of 1,269 children on a monthly basis. The Agency issued \$4,459,106 million in direct payments to child care providers in Fiscal Year 2012-2013.

Family Services Specialists assigned to the Foster Care unit partner with Social Workers, Probation Officers, Foster Care Providers, and Adoptive Parents to ensure that the children who are at-risk in our county are protected, safe, and their needs are provided for while they are in foster care placements. Effective January 1, 2012, Assembly Bill 12 Extended Foster Care (EFC) allows benefits to youth up to the age of 21. The FSS ensures continued financial assistance to support these youth. The Foster Care FSS also make

sure that the County's emancipated foster youth are connected to services they need to sustain self-sufficiency after they leave foster care by bridging the Foster Care program with CalFresh and Medi-Cal for seamless transition. Foster Care Family Services Specialists serve an average of 1,718 children per month in our county with approximately \$2.3 million in Foster Care, Adoption, KinGap, and Transitional Housing Program Plus benefits being issued on a monthly basis.

General Assistance is supported through the County General Fund. Family Services Specialists provide guidance and professional advocacy services to assist customers with the Social Security application process. As the result of this Supplemental Security Income (SSI) advocacy program, \$189,505 was recovered in assistance repayments in Fiscal Year 2012-2013.

Family Services Specialists in the Agency's Program Integrity Section are recognized for their commitment to a high level of program integrity. The Special Investigations Unit (SIU) is responsible for the prevention, detection and investigation of welfare fraud. In Fiscal Year 2012-2013, Family Services Specialists in SIU were responsible for setting up \$1,379,882 million in overpayments and over issuances. This is .5% of the total benefits issued.

Program integrity and accuracy are also reflected in audit results. The programs administered by Family Services Specialists meet the performance standards set forth by the Department of Health Services, the Department of Social Services, and Department of Education. The role of the Family Services Specialists in the Agency's Appeals Unit is to resolve applicant disputes on actions taken by the County. If the dispute is not resolved the FSS defends the County action before an Administrative Law Judge in a state hearing. In Fiscal Year 2012-2013 there were 1,029 hearing requests. Over 92% of the hearing requests were resolved prior to the scheduled hearing. Family Services Specialists in the Quality Control (QC) Unit receive a random sampling of cases to review and verify conformity with State and Federal tolerance levels for accuracy. In Federal Fiscal Year 2012 the accuracy rate for CalFresh benefits was 95%.

Family Services Specialists providing service in Stanislaus County have experienced significant caseload increases in recent years. Like many valley counties, the prolonged economic decline in Stanislaus County has had significant and profound impacts on many individuals and families. High foreclosure rates and the remaining high unemployment rates have made it difficult for customers who have been struggling to recover financially. The unemployment rate in the County drastically increased from 8% in 2006 to an average of 17% in Fiscal Year 2010-2011. As of October 2012, the double-digit rate was 13.9%. As a result, the number of residents accessing and receiving services administered by the Agency has grown to over 196,461 in Fiscal Year 2012-2013. From Fiscal Year 2009-2010 to Fiscal Year 2012-2013, the Agency experienced the following changes in most of its public assistance programs: decrease of .5% in CalWORKs, decrease of 40.5% percent in General Assistance, increase of 33.5% in CalFresh, increase of 9% in Medi-Cal, and less than 1.7% decrease in Foster Care.
