FISCAL IMPACT: Continued

Original funding for the project was identified through Homeland Security Grants awarded to Stanislaus County Office of Emergency Services and Community Oriented Policing Services (COPS) Technology Program funding awarded to the Sheriff's Department and the Modesto Police Department. Due to the timing of the next phase of the project, the remaining Fiscal Year 2009 and Fiscal Year 2010 Homeland Security Funding was expiring and was dedicated to other related projects. The remaining available funding from the COPS grants is \$557,305, which will expire March 2015.

In the first phase of the project, Tait North America, Inc. was to submit a schematic design for the 5-site and base station infrastructure and provide general project oversight; communication equipment was to be procured; the Turlock Police Department site, the SR911 Base station and the Ceres Police Department site was to be completed. In order to ensure that the funding source was not lost due to timing, the Project Manager authorized Tait North America, Inc. to purchase equipment with the available funding and consequently the Ceres Police Department site was not fully completed.

While the original RFP contemplated both phases of the project, only the first phase was originally awarded to Tait North America, Inc. Since Tait North America, Inc., prepurchased equipment for the second phase and has full understanding and background with the project, they are the logical vendor for this second phase of the project. The quote for the second phase from the vendor is \$436,932. This includes the completion of the Ceres Police Department, 1010 Tenth Street and Modesto Fire Station 9 sites and the partial completion of work on Modesto Fire Station 6.

There is an additional cost of \$84,224 with Motorola for Radio Firmware upgrade, \$15,000 set aside for miscellaneous costs including cabling, electrical parts, antenna etc., leaving \$21,149 available for project contingencies or for future project phases.

The \$557,305 funding is comprised of \$257,305 from Modesto COPS grant and \$300,000 from Sheriff's COPS Grant. These grants are technology grants and are not eligible for any construction costs related to the project. The Modesto Police Department is in the process of obtaining funding for the construction costs, not to exceed \$130,000. These costs are equivalent to the purchase of radios from the COPS funding.

The Board of Supervisors authorized acceptance of the \$300,000 COPS grant on October 26, 2010. These funds have been included in the Fiscal Year 2014-2015 Final Budget Sheriff – Operations budget.

DISCUSSION:

Project 25 (P-25) Linear Simulcast Trunking Radio System is part of a multi phase Regional Interoperable Communication system for Stanislaus County first responders. P-25 is a suite of standards for digital radio communications for use by federal, state and local public safety agencies in North America to enable them to communicate with other agencies and mutual aid response teams in emergencies.

A Request for Proposal was issued and on April 3, 2012 the Board of Supervisors approved an Agreement with Tait North America, Inc. As part of the first phase of the project, Tait North America, Inc. submitted a schematic design for the 5-site and base station infrastructure and provided general project oversight; communication equipment was procured; the Turlock Police Department site and the SR911 Base station was completed and the Ceres Police Department site was nearly completed. Phase II of this project will complete the Ceres Police Department, 1010 Tenth Street and Modesto Fire Station 9 sites, and begin work on the Modesto Fire Station 6 site. A future phase will be the completion of Fire Station 6 which will be funded by a Homeland Security Grant.

Tait North America, Inc. has nearly completed its contractual obligation, and the next phase of work has been identified with a cost estimate of \$436,932. This will include construction, equipment and installation of the equipment.

An additional cost of \$84,224 will be with Motorola for Radio Firmware upgrade. Stanislaus County Public Safety Departments have a number of existing Motorola P24 subscriber units that require a firmware up-grade in order to work with the new County wide P25 Simulcast Trunking system. This proprietary firmware option is only available from Motorola. No other radio manufacturer can produce or sell this firmware option for the Motorola radio equipment. General Services Agency (GSA) has been consulted and has confirmed that an agreement with Motorola will be a sole source and therefore a Request for Proposal is not required.

The remaining amount of \$15,000 is set aside for miscellaneous costs including cabling, electrical parts, antenna etc. and \$21,149 is available for project contingencies or for future project phases.

This project is crucial for Stanislaus County and its public safety and associated agencies to be able to provide the best level of service by allowing the partnerships that have been established between agencies to have an operable and interoperable communication systems. This system will effectively serve the various communities within the County and partner agencies in the region.
