

The meeting was called to order at 12:10 PM

Chairman Jeff Foster welcomed Executive Committee members and guests and reminded members of the Conflict of Interest rules. He then offered a chance for a public comment period. There was no comment from the general public. There was no chairman's report.

CEO REPORT

Dave first covered the scorecard. He explained that for 2015, there will be additional stretch goals added. He reported that unemployment in Modesto is currently in the single digits. In marketing, Dave explained the attached draft of the engagement matrix. He talked about all of the upcoming events such as Celebrate Stanislaus, the Economic Summit, and State of the City. Dave shared the plan for the 'Start Here, Work Here, Live Here' pieces. He shared that we are planning an aggressive LinkedIn Campaign. In business development, it was shared that the county seems to be running out of inventory of sites. Site selectors and brokers are trying to find creative ways to have additional inventory opportunities. With the Local Industry Program, there were a few interesting discoveries after a year of surveys. The biggest concerns for employers are transportation related. The condition of the airport is an issue as well as the condition of the streets and roads. The report explained that most companies surveyed are looking to expand in the next year.

In workforce development, companies have been having a hard time finding the people with the improving economy. Alliance Worknet is looking into providing programs with higher tech skills to train skilled workers for in demand positions.
